1 AN ACT concerning

State Police Retirement System - Transfers of Service Credit - Time Limitations - Exception

4 FOR the purpose of providing an exception to the time limitations for certain

- 5 transfers of service credit by certain members of the State Police Retirement
- 6 System; providing for procedures in the transfer; providing for the application of
- 7 this Act; providing for the termination of this Act; and generally relating to

8 transfers of service credit by members of the State Police Retirement System.

9 BY repealing and reenacting, without amendments,

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

15 MARYLAND, That the Laws of Maryland read as follows:

18 (a) This section does not apply to a transfer of service credit to or from the

- 19 State Contributory Employees' Pension System or the State Contributory Teachers'
- 20 Pension System.

1 (b) (1) An individual may not transfer service credit under this title unless 2 the individual makes a claim for the service credit within 1 year after becoming a 3 member of the new system.

4 (2) An individual may not transfer service credit from one contributory 5 system to another contributory system unless within 1 year after becoming a member 6 of the new system the individual deposits in the annuity savings fund or other 7 corresponding fund of the new system the total accumulated contributions to the 8 individual's credit in the annuity savings fund or other corresponding fund of the 9 previous system.

10 (c) Except as provided in § 37-204 of this subtitle, an individual who transfers 11 service credit under this title shall receive service credit in the new system in the 12 amount of service credit accumulated under the previous system.

13 (d) On verification of the service credit, the previous system may not provide
14 any benefit for service credit transferred from the previous system to a new system
15 under this title.

16 (e) (1) Except as provided in paragraph (2) of this subsection, if an 17 individual transfers service credit under this title, the previous system shall refund 18 the individual's accumulated contributions on request.

19 (2) Accumulated contributions applicable to the receipt of service credit 20 or benefits in the new system may not be refunded if:

(i) an individual transfers from one noncontributory system to
 another noncontributory system; or

(ii) a former member transfers under § 37-202(b) of this subtitle.

24 (f) (1) Except as otherwise provided in this subsection, after an individual 25 transfers service credit to a new system under this title, the individual:

26 (i) shall pay the rate of contribution applicable to a member of the 27 new system; and

(ii) is eligible for a pension and annuity as provided under the new
system, determined by taking into account the transferred service credit.

30 (2) Except as provided in § 37-204 of this subtitle, if an individual

31 transfers from a noncontributory system to a contributory system, on retirement the

32 individual's retirement allowance shall be reduced by the actuarial equivalent of the

33 accumulated contributions that would have been deducted if the individual had

34 earned the transferred service credit under the new system, including interest on

35 those contributions.

36 (3) If an individual retires within 5 years after transferring into a new 37 system, the benefits payable with respect to the transferred service credit may not be

1 greater than the benefits that would have been payable by the previous system with 2 respect to that service if the individual had remained in the previous system.

SECTION 2. AND BE IT FURTHER ENACTED, That the time limitations
described in § 37-203(b) of the State Personnel and Pensions Article do not apply to a
member of the State Police Retirement System who:

6 (1) made a claim to transfer service credit under Title 37 within 1 year 7 after becoming a member but the claim was not processed; and

8 (2) submits a completed claim form to the State Retirement Agency and 9 deposits in the annuity savings fund of the State Police Retirement System the 10 member's total accumulated contributions from the previous system.

11 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall be

12 construed retroactively and shall be applied to and interpreted to affect only13 individuals who became members of the State Police Retirement System on or after14 January 1, 2000.

15 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 July 1, 2002. It shall remain effective for a period of 12 months and, at the end of June 17 30, 2003, with no further action required by the General Assembly, this Act shall be 18 abrogated and of no further force and effect.
