- 3 FOR the purpose of increasing the membership of the Commissioners of the Housing
- 4 Authority of St. Mary's County; providing for the terms of certain

- 17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 18 MARYLAND, That the Laws of Maryland read as follows:
- 19 Article 44A Housing Authorities
- 20 TITLE 11. HOUSING AUTHORITY OF ST. MARY'S COUNTY.
- 21 11-101.
- 22 TITLE 1 OF THIS ARTICLE SHALL APPLY TO THE HOUSING AUTHORITY OF ST.
- 23 MARY'S COUNTY TO THE EXTENT IT IS NOT INCONSISTENT WITH THIS TITLE.
- 24 11-102.
- 25 (A) NOTWITHSTANDING § 1-206(A) OF THIS ARTICLE, FROM JULY 1, 2002 THE
- 26 HOUSING AUTHORITY OF ST. MARY'S COUNTY SHALL BE COMPOSED OF SEVEN
- 27 PERSONS.

- 1 (B) THE FIVE PERSONS SERVING AS COMMISSIONERS OF THE AUTHORITY ON
- 2 JULY 1, 2002 SHALL CONTINUE TO SERVE UNTIL THEIR RESPECTIVE TERMS EXPIRE
- 3 AND THEIR SUCCESSORS HAVE BEEN APPOINTED AND QUALIFIED.
- 4 (C) THE COMMISSIONERS FOR ST. MARY'S COUNTY SHALL DESIGNATE TWO
- 5 ADDITIONAL PERSONS TO SERVE AS COMMISSIONERS, ONE OF WHOM SHALL BE
- 6 APPOINTED FOR A TERM OF 1 YEAR AND THE OTHER FOR A TERM OF 2 YEARS, FROM
- 7 THEIR RESPECTIVE DATES OF APPOINTMENT. THEREAFTER THEIR SUCCESSORS
- 8 SHALL BE APPOINTED FOR TERMS OF 5 YEARS EACH EXCEPT THAT VACANCIES
- 9 SHALL BE FILLED FOR THE UNEXPIRED TERM.
- SECTION 2. AND BE IT FURTHER ENACTED, That nothing in this Act affects
- 11 the term of an appointed Commissioner of the Housing Authority of St. Mary's
- 12 County. A Commissioner of the Housing Authority of St. Mary's County on the
- 13 effective date of this Act shall remain a Commissioner for the balance of the term for
- 14 which appointed, unless the Commissioner dies, resigns, or is removed under
- 15 provisions of law.
- SECTION 3. AND BE IT FURTHER ENACTED, That nothing in this Act shall
- 17 preclude the County Commissioners for St. Mary's County from renaming the
- 18 Housing Authority of St. Mary's County in accordance with Article 44A, § 1-203(a) of
- 19 the Annotated Code of Maryland.
- 20 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 21 July 1, 2002.
