- 4 FOR the purpose of requiring a county or municipal corporation that allows a
- 5 charitable umbrella organization to conduct a charitable campaign using the

- 7 charitable organizations to participate in the charitable campaign; requiring the
- 8 county or municipal corporation to establish reasonable procedures to include

- certain charitable organization may not be charged a fee to participate in a
- charitable campaign; defining a certain term; and generally relating to

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 20 MARYLAND, That the Laws of Maryland read as follows:
- 21 Article 24 Political Subdivisions Miscellaneous Provisions

- 23 (A) IN THIS SECTION, "ELIGIBLE CHARITABLE ORGANIZATION" MEANS A
- 24 CHARITABLE ORGANIZATION THAT IS DESIGNATED AS A PARTICIPATING AGENCY IN
- 25 THE MARYLAND CHARITY CAMPAIGN FOR STATE EMPLOYEES AND RETIREES.
- 26 (B) A COUNTY OR MUNICIPAL CORPORATION THAT ALLOWS A CHARITABLE
- 27 UMBRELLA ORGANIZATION TO CONDUCT A CHARITABLE CAMPAIGN USING THE
- 28 COUNTY'S OR MUNICIPAL CORPORATION'S PAYROLL DEDUCTION SYSTEM SHALL:

- 1 (1) ALLOW AN ELIGIBLE CHARITABLE ORGANIZATION TO PARTICIPATE
- 2 IN THE CHARITABLE CAMPAIGN, WHETHER OR NOT THE ELIGIBLE CHARITABLE
- 3 ORGANIZATION IS A MEMBER ORGANIZATION OF THE CHARITABLE UMBRELLA
- 4 ORGANIZATION CONDUCTING THE CHARITABLE CAMPAIGN; AND
- 5 (2) ESTABLISH REASONABLE PROCEDURES TO INCLUDE AN ELIGIBLE 6 CHARITABLE ORGANIZATION IN THE CHARITABLE CAMPAIGN.
- 7 (C) AN ELIGIBLE CHARITABLE ORGANIZATION MAY NOT BE CHARGED A FEE 8 TO PARTICIPATE IN A CHARITABLE CAMPAIGN.
- 9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 June 1, 2002.
