HOUSE JOINT RESOLUTION

1 A House Joint Resolution concerning

2 **Legislative Districting Plan of 2002**

3 FOR the purpose of establishing a plan for legislative districts presented by the  
4 Governor pursuant to Article III, Section 5 of the Constitution of Maryland;  
5 providing that this Joint Resolution shall be effective as a plan within the  
6 meaning of Article III, Section 5 of the Constitution of Maryland only under  
7 certain circumstances; providing that this Joint Resolution does not preclude  
8 the enactment by the General Assembly of a subsequent Joint Resolution setting  
9 forth the boundaries of legislative districts; and generally relating to the  
10 establishment of legislative districts pursuant to Article III of the Constitution  
11 of Maryland.

3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
4 MARYLAND, That Section(s) 2-202 of Article - State Government of the Annotated  
5 Code of Maryland be repealed.

6 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
7 read as follows:

8 **Article - State Government**

9 Subtitle 2. Legislative Districting Plan of [1992] 2002.  
10 2-201.

11 (a) The State of Maryland is divided into 47 districts for the election of  
12 members of the General Assembly of Maryland.

13 (b) Each legislative district shall elect 1 Senator and 3 Delegates.

14 (c) Each legislative district may be subdivided into 3 single member delegate  
15 districts or into 1 single member delegate district and 1 multimember delegate  
16 district.

17 (d) In any legislative district which contains more than 2 counties or parts of  
18 more than 2 counties[:

19 (1)] where Delegates are to be elected at large by the voters of the entire  
20 district, a county, or part of a county, may not have more than 1 Delegate residing in  
21 that district[; and

22 (2) where the Delegates are to be elected by the voters of a multimember  
23 subdistrict which contains more than 2 counties or parts of more than 2 counties, a  
24 county or a part of a county may not have more than 1 Delegate residing in that  
25 subdistrict].

26 (e) (1) The descriptions of legislative districts in this subtitle, including all  
27 references to:

28 (i) election districts and wards are to the geographical boundaries  
29 of the election districts and wards as they existed as of April 1, [1990] 2000; and

30 (ii) precincts are to the geographical boundaries of the precincts as  
31 reviewed and certified by the local board of supervisors of elections or their designees,  
32 before they were reported to the U.S. Bureau of the Census as part of the [1990] 2000  
33 Census Redistricting Data Program and as those precinct lines are specifically  
34 INDICATED IN THE P.L. 94-171 DATA OR shown on the P.L. 94-171 census block maps  
35 provided by the U.S. Bureau of the Census and as reviewed and corrected by the  
36 Maryland Department of Planning.

1           (2)     Where precincts are split between legislative districts, census tract  
2 and block numbers, as INDICATED IN THE P.L. 94-171 DATA OR shown on the P.L.  
3 94-171 census block maps provided by the U.S. Bureau of the Census and referred to  
4 in § 2-202, are used to define the boundaries of legislative districts. [All other  
5 descriptions of split precincts appearing in § 2-202 are provided for informational  
6 purposes and may not be considered to be legally binding.]
