HOUSE JOINT RESOLUTION

1 A House Joint Resolution concerning

2 **Legislative Districting Plan of 2002**

3 FOR the purpose of establishing a plan for legislative districts pursuant to Article III,  
4 Section 5 of the Constitution of Maryland; providing that this Joint Resolution  
5 shall be effective as a plan within the meaning of Article III, Section 5 of the  
6 Constitution of Maryland only under certain circumstances; and generally  
7 relating to the establishment of legislative districts pursuant to Article III of the  
8 Constitution of Maryland.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
2 MARYLAND, That Section(s) 2-202 of Article - State Government of the Annotated  
3 Code of Maryland be repealed.

4 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland  
5 read as follows:

6 **Article - State Government**

7 Subtitle 2. Legislative Districting Plan of [1992] 2002.  
8 2-201.

9 (a) The State of Maryland is divided into 47 districts for the election of  
10 members of the General Assembly of Maryland.

11 (b) Each legislative district shall elect 1 Senator and 3 Delegates.

12 (c) Each legislative district may be subdivided into 3 single member delegate  
13 districts or into 1 single member delegate district and 1 multimember delegate  
14 district.

15 (d) In any legislative district which contains more than 2 counties or parts of  
16 more than 2 counties[:

17 (1) where Delegates are to be elected at large by the voters of the entire  
18 district, a county, or part of a county, may not have more than 1 Delegate residing in  
19 that district[; and

20 (2) where the Delegates are to be elected by the voters of a multimember  
21 subdistrict which contains more than 2 counties or parts of more than 2 counties, a  
22 county or a part of a county may not have more than 1 Delegate residing in that  
23 subdistrict].

24 (e) (1) The descriptions of legislative districts in this subtitle, including all  
25 references to:

26 (i) election districts and wards are to the geographical boundaries  
27 of the election districts and wards as they existed as of April 1, [1990] 2000; and

28 (ii) precincts are to the geographical boundaries of the precincts as  
29 reviewed and certified by the local board of supervisors of elections or their designees,  
30 before they were reported to the U.S. Bureau of the Census as part of the [1990] 2000  
31 Census Redistricting Data Program and as those precinct lines are specifically  
32 INDICATED IN THE P.L. 94-171 DATA OR shown on the P.L. 94-171 census block maps  
33 provided by the U.S. Bureau of the Census and as reviewed and corrected by the  
34 Maryland Department of Planning.

35 (2) Where precincts are split between legislative districts, census tract  
36 and block numbers, as INDICATED IN THE P.L. 94-171 DATA OR shown on the P.L.

1 94-171 census block maps provided by the U.S. Bureau of the Census and referred to  
2 in § 2-202, are used to define the boundaries of legislative districts. [All other  
3 descriptions of split precincts appearing in § 2-202 are provided for informational  
4 purposes and may not be considered to be legally binding.]

17 unconstitutionality or invalidity had been known. To this end, all parts of this subtitle  
18 are declared to be severable.

19 SECTION 3. AND BE IT FURTHER RESOLVED, That this Joint Resolution  
20 shall be construed as setting forth the boundaries for legislative districts pursuant to  
21 the provisions of the fourth and fifth sentences of Article III, Section 5 of the  
22 Constitution of Maryland and shall be effective as a plan within the meaning of those  
23 provisions only if the plan is adopted by the General Assembly pursuant to those  
24 provisions by the 45th day of the 2002 regular Session.
