A CONSOLIDATED SENIOR VETERANS' SPORT FISHING LICENSE: 20 (C) 21 (1) IS VALID FOR A PERIOD NOT EXCEEDING 1 YEAR; AND 22 (2) EXPIRES ON DECEMBER 31 OF THE YEAR OF ISSUANCE. 23 4-604. 24 (c) Any person 16 years old or older shall secure an angler's license to fish in 25 the nontidal waters of the State. An angler's license entitles the holder to fish in the nontidal waters of the State only during the open season. 27 (d) An angler's license is not required of the following: The owner or tenant of land bordering on nontidal water, his spouse 28 (1) 29 and children, or the spouse of any child who resides on the land with the owner or 30 tenant when he fishes in nontidal water adjoining his land; 31 Any convalescent patient of a veterans' hospital hospitalized for a

The stamp shall be obtained from any authorized agent of the Department at a cost of \$5. The Department may designate a person engaged in a retail business to sell the trout stamp as an agent under the Department's control and supervision. The trout stamps may be furnished to agents upon consignment if the Department is given adequate security to insure ultimate payment to the Department for the stamps.
