1 AN ACT concerning

2 **Motor Vehicle Administration - Chesapeake Bay Commemorative License**  
3 **Plate Program - Extension**

4 FOR the purpose of extending the termination date of the Chesapeake Bay  
5 Commemorative License Plate Program until a certain date; and generally  
6 relating to the Chesapeake Bay Commemorative License Plate Program.

7 BY repealing and reenacting, without amendments,  
8 Article - Transportation

12 BY repealing and reenacting, with amendments,  
13 Chapter 3 of the Acts of the General Assembly of the First Special Session of  
14 1992, as amended by Chapter 91 of the Acts of the General Assembly of

1 1994, Chapter 356 of the Acts of the General Assembly of 1996, Chapter  
2 141 of the Acts of the General Assembly of 1998, and Chapter 340 of the  
3 Acts of the General Assembly of 2000  
4 Section 3

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
6 MARYLAND, That the Laws of Maryland read as follows:

7 **Article - Transportation**

8 13-618.

9 (c) (1) An original or substitute commemorative plate may only be issued  
10 under this section for a fixed period of 2 consecutive years after its initial issuance.

11 (2) The Administration may only issue 1 commemorative plate under  
12 this section at any one time.

13 **Chapter 3 of the Acts of the First Special Session of 1992, as amended by**  
14 **Chapter 91 of the Acts of 1994, Chapter 356 of the Acts of 1996, Chapter 141 of**  
15 **the Acts of 1998, and Chapter 340 of the Acts of 2000**

16 SECTION 3. AND BE IT FURTHER ENACTED, That, notwithstanding the  
17 provisions of § 13-618(c) of the Transportation Article, the Motor Vehicle  
18 Administration shall extend the Chesapeake Bay Commemorative Plate Program  
19 until July 1, [2002] ~~2008~~ 2007.

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
21 June 1, 2002.
