30 WHEREAS, The General Assembly has identified as a priority the development

31 of strategies to prepare children to enter school ready to learn; and

- WHEREAS, Recent neurological research strongly supports the proposition that
- 2 young children's social and emotional development before they enter school is an
- 3 essential foundation to young children's learning skills and later school success; and
- 4 WHEREAS, The National Academy of Sciences has concluded that enhancement
- 4 WIEREAS, The National Academy of Sciences has concluded that enhance
- 5 of social and emotional development is as important in early childhood as
- 6 enhancement of linguistic and cognitive competence and has recommended that
- 7 resources similar to those focused on literacy and numerical skills should be devoted
- 8 to promoting young children's social and emotional development; and
- 9 WHEREAS, Few early childhood programs supported by the State and federal
- 10 government have sufficient capacity to address the emotional and social
- 11 developmental needs of eligible children and their families with prevention and early
- 12 intervention services; and
- 13 WHEREAS, Research overwhelmingly demonstrates that a child's development
- 14 is deeply influenced by relationships with parents, the behavior of parents, and early
- 15 interventions with eligible children and their families can increase the probability of
- 16 healthy development and academic success; and
- 17 WHEREAS, Second to the influence of immediate family, child care providers
- 18 shape children's emotional and social development with 61% of children under the age
- 19 of 4 years in regularly scheduled child care with someone other than a parent; and
- WHEREAS, The United States Surgeon General's Conference on Children's
- 21 Mental Health has recommended the creation of tangible tools for early childhood
- 22 service providers to assist in assessment of children's social and emotional needs, to
- 23 discuss children's needs with the families, and to make referrals for families; and
- 24 WHEREAS, The Maryland State Early Childhood Mental Health Steering
- 25 Committee of the Subcabinet for Children, Youth, and Families has been working on
- 26 a plan to integrate mental health services into existing early childhood programs, is
- 27 in the process of mapping existing early childhood mental health services in each
- 28 jurisdiction in collaboration with local management boards, and has made
- 29 recommendations for development of a comprehensive, integrated early childhood
- 30 mental health system of care for Maryland's children; and
- 31 WHEREAS, Early intervention for children with social and emotional
- 32 development needs can lead to later savings in public expenditures for special
- 33 education, income support, and criminal justice; and
- WHEREAS, The healthy social and emotional development of young children in
- 35 this State is critical to meeting the goal of children entering school ready to learn;

- 24 Committee and the House Appropriations Committee on or before August 1, 2002, in
- 25 accordance with § 2-1246 of the State Government Article, on the comprehensive plan
- 26 required under this Act for the establishment of a system to promote early childhood
- 27 social and emotional development and school readiness of children under the age of 6
- 28 years.

- 30 June 1, 2002.
