A BILL ENTITLED

1 AN ACT concerning

2 Creation of a State Debt - Montgomery County - The Link - Ages Place

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$500,000,
- 4 the proceeds to be used as a grant to the Board of Trustees of Christ
- 5 Congregational Church, Inc. for certain development or improvement purposes;
- 6 providing for disbursement of the loan proceeds, subject to a requirement that
- 7 the grantee provide and expend a matching fund; prohibiting use of the proceeds
- 8 of the sale of the bonds and the matching fund for religious purposes; and
- 9 providing generally for the issuance and sale of bonds evidencing the loan.

10~ SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

11 MARYLAND, That:

- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the Montgomery
- 14 County The Link Ages Place Loan of 2002 in a total principal amount equal to the
- 15 lesser of (i) \$500,000 or (ii) the amount of the matching fund provided in accordance
- 16 with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and
- 17 delivery of State general obligation bonds authorized by a resolution of the Board of
- 18 Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 19 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 20 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 21 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 22 § 8-122 of the State Finance and Procurement Article.
- 23 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 24 and first shall be applied to the payment of the expenses of issuing, selling, and
- 25 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 26 shall be credited on the books of the Comptroller and expended, on approval by the
- 27 Board of Public Works, for the following public purposes, including any applicable
- 28 architects' and engineers' fees: as a grant to the Board of Trustees of Christ
- 29 Congregational Church, Inc. (referred to hereafter in this Act as "the grantee") for the
- 30 planning, design, repair, reconstruction, renovation, and capital equipping of a facility
- 31 located at 9525 Colesville Road in Silver Spring, Maryland, for use as an
- 32 intergenerational center where both older and younger individuals can participate in

- 1 academic and cultural programs designed to integrate the community and stimulate 2 learning across generational lines.
- 3 (4) An annual State tax is imposed on all assessable property in the State in 4 rate and amount sufficient to pay the principal of and interest on the bonds, as and 5 when due and until paid in full. The principal shall be discharged within 15 years 6 after the date of issuance of the bonds.
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the
- 8 purposes set forth in Section 1(3) above, the grantee shall provide and expend a purpose find No part of the grantee's matching fund may be provided either.
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property or in kind
- 12 contributions. The fund may consist of funds expended prior to the effective date of
- 13 this Act. In case of any dispute as to the amount of the matching fund or what money
- 14 or assets may qualify as matching funds, the Board of Public Works shall determine
- 15 the matter and the Board's decision is final. The grantee has until June 1, 2004, to
- 16 present evidence satisfactory to the Board of Public Works that a matching fund will
- 17 be provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 18 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 19 equal to the amount of the matching fund shall be expended for the purposes provided
- 20 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 21 certified by the Board of Public Works shall be canceled and be of no further effect.
- 22 (6) No portion of the proceeds of the loan or any of the matching funds may be
- 23 used for the furtherance of sectarian religious instruction, or in connection with the
- 24 design, acquisition, or construction of any building used or to be used as a place of
- 25 sectarian religious worship or instruction, or in connection with any program or
- 26 department of divinity for any religious denomination. Upon the request of the Board
- 27 of Public Works, the grantee shall submit evidence satisfactory to the Board that none
- 28 of the proceeds of the loan or any matching funds have been or are being used for a
- 29 purpose prohibited by this Act.
- 30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take
- 31 effect June 1, 2002.
