A BILL ENTITLED

1 AN ACT concerning

2 Creation of a State Debt - Sacred Heart Hospital

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$545,000,
- 4 the proceeds to be used as a grant to the Board of Directors of Sacred Heart
- 5 Hospitals of the Sisters of Charity, Inc. for certain development or improvement
- 6 purposes; providing for disbursement of the loan proceeds, subject to a
- 7 requirement that the grantee provide and expend a matching fund; prohibiting
- 8 the use of the proceeds of the sale of the bonds or the matching fund for
- 9 sectarian religious purposes; and providing generally for the issuance and sale
- of bonds evidencing the loan.

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

- 12 MARYLAND, That:
- 13 (1) The Board of Public Works may borrow money and incur indebtedness on
- 14 behalf of the State of Maryland through a State loan to be known as the Sacred Heart
- 15 Hospital Loan of 2002 in a total principal amount equal to the lesser of (i) \$545,000 or
- 16 (ii) the amount of the matching fund provided in accordance with Section 1(5) below.
- 17 This loan shall be evidenced by the issuance, sale, and delivery of State general
- 18 obligation bonds authorized by a resolution of the Board of Public Works and issued,
- 19 sold, and delivered in accordance with §§ 8-117 through 8-124 of the State Finance
- 20 and Procurement Article and Article 31, § 22 of the Code.
- 21 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 22 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 23 § 8-122 of the State Finance and Procurement Article.
- 24 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 25 and first shall be applied to the payment of the expenses of issuing, selling, and
- 26 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 27 shall be credited on the books of the Comptroller and expended, on approval by the
- 28 Board of Public Works, for the following public purposes, including any applicable
- 29 architects' and engineers' fees: as a grant to the Board of Directors of Sacred Heart
- 30 Hospitals of the Sisters of Charity, Inc. (referred to hereafter in this Act as "the
- 31 grantee") for the planning, design, renovation, repair, construction, and capital

- 1 equipping of the emergency department, to be located at 900 Seton Drive in 2 Cumberland.
- 3 (4) An annual State tax is imposed on all assessable property in the State in 4 rate and amount sufficient to pay the principal of and interest on the bonds, as and 5 when due and until paid in full. The principal shall be discharged within 15 years
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the 8 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property or in kind
- 12 contributions. The fund may consist of funds expended prior to the effective date of
- 13 this Act. In case of any dispute as to the amount of the matching fund or what money
- 14 or assets may qualify as matching funds, the Board of Public Works shall determine
- 15 the matter and the Board's decision is final. The grantee has until June 1, 2004, to
- 16 present evidence satisfactory to the Board of Public Works that a matching fund will
- 17 be provided. If satisfactory evidence is presented, the Board shall certify this fact and
- 18 the amount of the matching fund to the State Treasurer, and the proceeds of the loan
- 19 equal to the amount of the matching fund shall be expended for the purposes provided
- 20 in this Act. Any amount of the loan in excess of the amount of the matching fund
- 21 certified by the Board of Public Works shall be canceled and be of no further effect.
- 22 (6) No portion of the proceeds of the loan or any of the matching funds may be
- 23 used for the furtherance of sectarian religious instruction, or in connection with the
- 24 design, acquisition, or construction of any building used or to be used as a place of
- 25 sectarian religious worship or instruction, or in connection with any program or
- 26 department of divinity for any religious denomination. Upon the request of the Board
- 27 of Public Works, the grantee shall submit evidence satisfactory to the Board that none
- 28 of the proceeds of the loan or any matching funds have been or are being used for a
- 29 purpose prohibited by this Act.

30 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take 31 effect June 1, 2002.
