- 2 Creation of a State Debt Calvert County Town of North Beach Fishing
 Pier
- 4 FOR the purpose of authorizing the creation of a State Debt in the amount of
- 5 \$100,000, the proceeds to be used as a grant to the Mayor and City Council of
- 6 the Town of North Beach for certain development or improvement purposes;
- 7 providing for disbursement of the loan proceeds, subject to a requirement that
- 8 the grantee provide and expend a matching fund; and providing generally for
- 9 the issuance and sale of bonds evidencing the loan.
- 10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 11 MARYLAND, That:
- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the Calvert
- 14 County Town of North Beach Fishing Pier Loan of 2002 in the total principal
- 15 amount of \$100,000. This loan shall be evidenced by the issuance, sale, and delivery of
- 16 State general obligation bonds authorized by a resolution of the Board of Public
- 17 Works and issued, sold, and delivered in accordance with §§ 8-117 through 8-124 of
- 18 the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 19 (2) The bonds to evidence this loan or installments of this loan may be sold as
- 20 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 21 § 8-122 of the State Finance and Procurement Article.
- 22 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 23 and first shall be applied to the payment of the expenses of issuing, selling, and
- 24 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 25 shall be credited on the books of the Comptroller and expended, on approval by the
- 26 Board of Public Works, for the following public purposes, including any applicable
- 27 architects' and engineers' fees: as a grant to the Mayor and City Council of the Town
- 28 of North Beach (referred to hereafter in this Act as "the grantee") for the planning,
- 29 design, and construction of an expansion to the Town of North Beach fishing pier
- 30 located adjacent to the Town's boardwalk.

- 1 (4) An annual State tax is imposed on all assessable property in the State in 2 rate and amount sufficient to pay the principal of and interest on the bonds, as and 3 when due and until paid in full. The principal shall be discharged within 15 years 4 after the date of issuance of the bonds.
- 5 Prior to the payment of any funds under the provisions of this Act for the (5) 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 7 matching fund of \$75,000. No part of the grantee's matching fund may be provided,
- 8 either directly or indirectly, from funds of the State, whether appropriated or
- 9 unappropriated. No part of the fund may consist of real property, in kind
- 10 contributions, or funds expended prior to the effective date of this Act. In case of any
- 11 dispute as to the amount of the matching fund or what money or assets may qualify
- 12 as matching funds, the Board of Public Works shall determine the matter and the
- 13 Board's decision is final. The grantee has until June 1, 2004, to present evidence
- 14 satisfactory to the Board of Public Works that a matching fund will be provided. If
- 15 satisfactory evidence is presented, the Board shall certify this fact to the State
- 16 Treasurer, and the proceeds of the loan shall be expended for the purposes provided in 17 this Act.
- 18 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 19 June 1, 2002.
