A BILL ENTITLED

1 AN ACT concerning

2 **Business Regulation - Lodging Establishments - Rights and Responsibilities**
3 **of Innkeepers**

4 FOR the purpose of authorizing an innkeeper to refuse lodging or services to or
5 remove from a lodging establishment an individual who is unwilling or unable
6 to pay for lodging or services, is under the influence of alcohol or drugs, is
7 disorderly, destroys or damages property of the lodging establishment or its
8 guests, is reasonably suspected of using the lodging establishment for the
9 possession or use of a controlled dangerous substance, is reasonably suspected of
10 using the lodging establishment for the consumption of alcohol by an individual
11 under the legal age, is reasonably suspected of possessing certain dangerous
12 items, or refuses to abide by certain rules of the lodging establishment;
13 requiring the innkeeper to provide a certain notice and refund certain payments
14 when removing an individual from a lodging establishment; establishing the
15 actions an innkeeper may take when removing an individual from a lodging
16 establishment; authorizing an innkeeper to require that a prospective guest
17 register, provide certain identification, and demonstrate an ability to pay for
18 lodging; authorizing an innkeeper to limit the number of individuals who may
19 occupy a room at a lodging establishment; authorizing an innkeeper to require
20 the parent or guardian of a guest who is a minor to accept liability for the
21 minor's lodging costs and any damages the minor causes and make an advance
22 deposit up to a certain amount; requiring an innkeeper to post certain
23 information; providing an innkeeper with immunity from criminal and civil
24 prosecution under certain circumstances; specifying that this Act does not alter
25 a certain prohibition against discrimination; defining certain terms; and
26 generally relating to the rights and responsibilities of innkeepers and lodging
27 establishments.

7 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
8 MARYLAND, That the Laws of Maryland read as follows:

9 **Article - Business Regulation**

10 Title 15. [Hotels] LODGING ESTABLISHMENTS.

11 SUBTITLE 1. HOTEL LIABILITY FOR VALUABLES.

12 15-101.

13 In this [title] SUBTITLE, "valuable" means money, jewelry, securities, or plate.

14 15-102.

15 Except for § 15-105 of this [title] SUBTITLE, this [title] SUBTITLE applies only
16 to those hotels that display in each guest room a notice of the provisions of this [title]
17 SUBTITLE.

18 SUBTITLE 2. RIGHTS AND RESPONSIBILITIES OF INNKEEPERS.

19 15-201.

20 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS
21 INDICATED.

22 (B) "INNKEEPER" MEANS THE OWNER, OPERATOR, MANAGER, OR KEEPER OF A
23 LODGING ESTABLISHMENT, OR THE AGENT OF AN OWNER, OPERATOR, MANAGER, OR
24 KEEPER OF A LODGING ESTABLISHMENT.

25 (C) "LODGING ESTABLISHMENT" MEANS AN INN, HOTEL, MOTEL, OR OTHER
26 ESTABLISHMENT THAT HAS AT LEAST SIX ROOMS AVAILABLE FOR A FEE TO
27 TRANSIENT GUESTS FOR LODGING OR SLEEPING PURPOSES.

29 EXCEPT AS PROVIDED IN THIS SUBTITLE FOR AN INDIVIDUAL WHO IS UNDER
30 THE AGE OF 18 YEARS, THIS SUBTITLE MAY NOT BE CONSTRUED TO ALTER THE
31 PROHIBITION AGAINST DISCRIMINATION BY AN INNKEEPER OR LODGING
32 ESTABLISHMENT ESTABLISHED UNDER ARTICLE 49B, § 5 OF THE CODE.

1 15-203.

2 (A) AN INNKEEPER MAY REFUSE TO PROVIDE LODGING OR SERVICES TO OR
3 MAY REMOVE FROM A LODGING ESTABLISHMENT AN INDIVIDUAL WHO:

4 (1) REFUSES TO PAY OR IS UNABLE TO PAY FOR LODGING OR SERVICES;

5 (2) WHILE ON THE PREMISES OF THE LODGING ESTABLISHMENT IS
6 UNDER THE INFLUENCE OF ALCOHOL, DRUGS, OR OTHER INTOXICATING
7 SUBSTANCE;

8 (3) WHILE ON THE PREMISES IS DISORDERLY SO AS TO CREATE A
9 PUBLIC NUISANCE;

10 (4) DESTROYS, DAMAGES, OR DEFACTS PROPERTY OF THE LODGING
11 ESTABLISHMENT OR ITS GUESTS, OR THREATENS TO DO SO;

12 (5) THE INNKEEPER REASONABLY BELIEVES IS USING THE LODGING
13 ESTABLISHMENT FOR THE UNLAWFUL POSSESSION OR USE OF A CONTROLLED
14 DANGEROUS SUBSTANCE IN VIOLATION OF TITLE 5 OF THE CRIMINAL LAW ARTICLE
15 OR FOR THE CONSUMPTION OF ALCOHOL BY AN INDIVIDUAL UNDER THE AGE OF 21
16 YEARS IN VIOLATION OF ARTICLE 2B, § 12-108 OF THE CODE;

17 (6) THE INNKEEPER REASONABLY BELIEVES POSSESSES PROPERTY
18 THAT MAY BE DANGEROUS TO OTHER INDIVIDUALS, SUCH AS FIREARMS OR
19 EXPLOSIVES; OR

20 (7) REFUSES TO ABIDE BY ANY CONSPICUOUSLY POSTED RULE OR
21 POLICY OF THE LODGING ESTABLISHMENT.

22 (B) (1) IF AN INNKEEPER SEEKS TO REMOVE AN INDIVIDUAL FROM A
23 LODGING ESTABLISHMENT AS PROVIDED UNDER THIS SECTION, THE INNKEEPER
24 SHALL:

25 (I) NOTIFY THE INDIVIDUAL, EITHER ORALLY OR IN WRITING,
26 THAT THE LODGING ESTABLISHMENT REFUSES TO PROVIDE FURTHER LODGING OR
27 SERVICES TO THE INDIVIDUAL AND THAT THE INDIVIDUAL SHOULD IMMEDIATELY
28 LEAVE THE LODGING ESTABLISHMENT; AND

29 (II) IF THE INDIVIDUAL HAS PAID FOR LODGING OR SERVICES IN
30 ADVANCE, REFUND ANY UNUSED PORTION OF THE ADVANCE PAYMENT, BUT THE
31 LODGING ESTABLISHMENT MAY WITHHOLD PAYMENT FOR A FULL DAY'S LODGING IF
32 THE INDIVIDUAL WAS LODGED FOR A PORTION OF A DAY.

33 (2) IF AN INDIVIDUAL ATTEMPTS TO REMAIN IN A LODGING
34 ESTABLISHMENT AFTER HAVING BEEN REQUESTED TO LEAVE UNDER THE
35 PROVISIONS OF THIS SECTION, AN INNKEEPER MAY:

36 (I) IF THE INDIVIDUAL IS A GUEST, LOCK THE DOOR OF THE
37 INDIVIDUAL'S ROOM;

1 (II) REMOVE THE INDIVIDUAL'S BAGGAGE AND OTHER PERSONAL
2 PROPERTY;

3 (III) USING NO MORE FORCE THAN NECESSARY, EJECT THE
4 INDIVIDUAL FROM THE LODGING ESTABLISHMENT;

5 (IV) COMMAND EMPLOYEES OF THE LODGING ESTABLISHMENT TO
6 ASSIST IN THE EJECTION OF THE INDIVIDUAL; AND

7 (V) IF THE INDIVIDUAL IS VIOLATING THE LAW, DETAIN THE
8 INDIVIDUAL UNTIL THE ARRIVAL OF LAW ENFORCEMENT AUTHORITIES.

9 15-204.

10 (A) AN INNKEEPER MAY REQUIRE A PROSPECTIVE GUEST TO DEMONSTRATE
11 AN ABILITY TO PAY BY CASH OR VALID CREDIT CARD.

12 (B) AN INNKEEPER MAY REQUIRE EACH GUEST AT A LODGING
13 ESTABLISHMENT TO REGISTER AND MAY REQUIRE THE GUEST TO PRODUCE A VALID
14 DRIVER'S LICENSE OR OTHER IDENTIFICATION SATISFACTORY TO THE INNKEEPER.

15 (C) AN INNKEEPER MAY LIMIT THE NUMBER OF INDIVIDUALS WHO MAY
16 OCCUPY A PARTICULAR GUEST ROOM IN A LODGING ESTABLISHMENT.

17 15-205.

18 (A) FOR AN INDIVIDUAL WHO IS UNDER THE AGE OF 18 YEARS, AN INNKEEPER
19 MAY REQUIRE A PARENT OR GUARDIAN OF THE INDIVIDUAL TO:

20 (1) ACCEPT LIABILITY FOR THE CHARGES FOR THE INDIVIDUAL'S
21 LODGING AND ANY DAMAGES TO THE LODGING ESTABLISHMENT CAUSED BY THE
22 INDIVIDUAL; AND

23 (2) PROVIDE A VALID CREDIT CARD OR MAKE AN ADVANCE CASH
24 DAMAGE DEPOSIT OF NOT MORE THAN \$500 TO COVER ANY CHARGES INCURRED OR
25 DAMAGES CAUSED BY THE INDIVIDUAL.

26 (B) IF AN INNKEEPER REQUIRES AN ADVANCE DEPOSIT UNDER SUBSECTION
27 (A) OF THIS SECTION, THE INNKEEPER SHALL, FOLLOWING A ROOM INSPECTION AT
28 THE TIME OF CHECKOUT, REFUND ANY AMOUNT OF THE DEPOSIT NOT NEEDED TO
29 COVER REASONABLE CHARGES FOR DAMAGES.

30 15-206.

31 AN INNKEEPER SHALL POST A COPY OF THIS SUBTITLE, TOGETHER WITH ALL
32 RULES OF THE LODGING ESTABLISHMENT, IN A CONSPICUOUS PLACE AT OR NEAR
33 THE GUEST REGISTRATION DESK AND IN EACH GUEST ROOM.

1 15-207.

2 EXCEPT AS PROVIDED UNDER § 15-202 OF THIS SUBTITLE, AN INNKEEPER WHO
3 REFUSES TO PROVIDE LODGING OR SERVICES TO AN INDIVIDUAL OR REMOVES AN
4 INDIVIDUAL FROM A LODGING ESTABLISHMENT UNDER THE PROVISIONS OF THIS
5 SUBTITLE MAY NOT BE HELD LIABLE IN ANY CIVIL OR CRIMINAL ACTION BASED
6 UPON THE REFUSAL OR REMOVAL.

7 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 October 1, 2002.
