	(a) The provisions of this section apply except as necessary to avoid conflict with other traffic or in compliance with law or the directions of a police officer or traffic control device.
6	(e) A person may not stop, stand, or park a vehicle on a crosswalk.
7 8	(n) (1) [A] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, A person may not stand or park a vehicle within 20 feet of a crosswalk at an intersection.
	(2) (I) THE GOVERNING BODY OF BALTIMORE CITY MAY REGULATE THE DISTANCE FROM A CROSSWALK AT AN INTERSECTION IN BALTIMORE CITY WITHIN WHICH A PERSON MAY NOT STAND OR PARK A VEHICLE.
