- 12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 13 MARYLAND, That the Laws of Maryland read as follows:

## 14 Article - Public Utility Companies

- 15 13-208.
- 16 (A) IN ADDITION TO ANY REMEDY OTHERWISE AVAILABLE, IF THE
- 17 COMMISSION DETERMINES THAT A PERSON HAS ENGAGED IN OR IS ABOUT TO
- 18 ENGAGE IN AN ACT OR PRACTICE THAT CONSTITUTES A VIOLATION OF ANY
- 19 PROVISION OF THIS ARTICLE OR ANY REGULATION, RULE, OR ORDER ADOPTED
- 20 UNDER THIS ARTICLE, AND THAT IMMEDIATE ACTION AGAINST THE PERSON IS IN
- 21 THE PUBLIC INTEREST, THE COMMISSION MAY ORDER THE PERSON TO CEASE AND
- 22 DESIST FROM THE ACT OR PRACTICE.
- 23 (B) AFTER THE COMMISSION ISSUES A CEASE AND DESIST ORDER. THE
- 24 ALLEGED VIOLATOR MAY SUBMIT A WRITTEN REQUEST FOR A HEARING TO THE
- 25 COMMISSION.

- 1 (C) A SUMMARY CEASE AND DESIST ORDER BECOMES FINAL IF THE ALLEGED 2 VIOLATOR DOES NOT REQUEST A HEARING WITHIN 15 DAYS AFTER RECEIVING THE
- 3 SUMMARY CEASE AND DESIST ORDER.
- 4 (D) THE HEARING SHALL BEGIN:
- $5\ \ \,$  (1) WITHIN 15 BUSINESS DAYS AFTER THE COMMISSION RECEIVES THE 6 REQUEST FOR A HEARING; OR
- 7 (2) WITH THE CONSENT OF THE ALLEGED VIOLATOR, AT A LATER DATE.
- 8 (E) IF THE COMMISSION DOES NOT BEGIN A TIMELY HEARING WITHIN THE
- 9 APPLICABLE TIME LIMIT PROVIDED IN SUBSECTION (D) OF THIS SECTION, THE
- 10 CEASE AND DESIST ORDER IS DEEMED RESCINDED.
- 11 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 12 October 1, 2002.
