A BILL ENTITLED

1 AN ACT concerning

2 **Motor Vehicle Administration - Drivers' Licenses and Identification Cards -**
3 **Selective Service Administration Registration**

4 FOR the purpose of requiring the Motor Vehicle Administration to provide to the
5 Selective Service Administration certain information concerning male
6 applicants of a certain age who apply for a driver's license or identification card
7 under certain circumstances; establishing that a signature on an application for
8 a driver's license or identification card constitutes consent to forwarding certain
9 information to the Selective Service Administration; requiring the Motor Vehicle
10 Administration to provide certain information on a certain application;
11 providing that an applicant's refusal to consent to certain information being sent
12 to the Selective Service Administration does not constitute grounds for denial of
13 a driver's license or identification card; requiring the Motor Vehicle
14 Administration to forward certain information to the Selective Service
15 Administration in a certain manner; and generally relating to drivers' licenses
16 and identification cards.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
23 MARYLAND, That the Laws of Maryland read as follows:

24 **Article - Transportation**

25 12-304.

26 (A) THIS SECTION APPLIES ONLY TO AN ADULT MALE APPLICANT UNDER THE
27 AGE OF 26 YEARS.

28 (B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, THE ADMINISTRATION
29 SHALL PROVIDE TO THE SELECTIVE SERVICE ADMINISTRATION IN AN ELECTRONIC

1 FORMAT, FOR PURPOSES OF REGISTRATION WITH THE SELECTIVE SERVICE AS
2 REQUIRED UNDER FEDERAL LAW, THE NECESSARY INFORMATION CONCERNING A
3 MALE APPLICANT WHO APPLIES FOR A DRIVER'S LICENSE OR IDENTIFICATION CARD
4 OR THE RENEWAL OF A DRIVER'S LICENSE OR IDENTIFICATION CARD, INCLUDING
5 THE APPLICANT'S:

6 (1) FULL NAME;

7 (2) CURRENT ADDRESS;

8 (3) DATE OF BIRTH;

9 (4) GENDER;

10 (5) DATE OF APPLICATION; AND

11 (6) SOCIAL SECURITY NUMBER, IF AVAILABLE.

12 (C) (1) A MALE APPLICANT'S SIGNATURE ON THE APPLICATION INDICATES
13 THAT THE APPLICANT:

14 (I) HAS ALREADY REGISTERED WITH THE SELECTIVE SERVICE
15 ADMINISTRATION; OR

16 (II) AUTHORIZES THE ADMINISTRATION TO FORWARD TO THE
17 SELECTIVE SERVICE ADMINISTRATION THE NECESSARY INFORMATION FOR
18 REGISTRATION.

19 (2) IN ADDITION TO THE INFORMATION REQUIRED UNDER THIS
20 SUBTITLE OR TITLE 16 OF THIS ARTICLE, AN APPLICATION FORM FOR A DRIVER'S
21 LICENSE OR IDENTIFICATION CARD OR RENEWAL OF A DRIVER'S LICENSE OR
22 IDENTIFICATION CARD SHALL:

23 (I) CONTAIN A STATEMENT THAT A MALE APPLICANT'S
24 SIGNATURE CONSTITUTES CONSENT TO FORWARDING THE INFORMATION IN
25 SUBSECTION (B) OF THIS SECTION TO THE SELECTIVE SERVICE ADMINISTRATION;
26 AND

27 (II) PROVIDE AN OPPORTUNITY FOR A MALE APPLICANT TO
28 REFUSE TO CONSENT TO THE FORWARDING OF THE INFORMATION IN SUBSECTION
29 (B) OF THIS SECTION TO THE SELECTIVE SERVICE ADMINISTRATION.

30 (D) REFUSAL TO CONSENT TO THE FORWARDING OF THE INFORMATION IN
31 SUBSECTION (B) OF THIS SECTION TO THE SELECTIVE SERVICE ADMINISTRATION
32 MAY NOT BE GROUNDS FOR DENIAL OF AN APPLICATION FOR A DRIVER'S LICENSE OR
33 IDENTIFICATION CARD OR RENEWAL OF A DRIVER'S LICENSE OR IDENTIFICATION
34 CARD.

35 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
36 October 1, 2002.
