1 AN ACT concerning

2 **Motor Vehicle Administration - Drivers' Licenses and Identification Cards -**  
3 **Selective Service Administration Registration**

4 FOR the purpose of requiring the Motor Vehicle Administration to provide to the  
5 Selective Service Administration certain information concerning male  
6 applicants of a certain age who apply for a driver's license or identification card  
7 under certain circumstances; establishing that a signature on an application for  
8 a driver's license or identification card constitutes consent to forwarding certain  
9 information to the Selective Service Administration; requiring the Motor Vehicle  
10 Administration to provide certain information on a certain application;  
11 ~~providing that an applicant's refusal to consent to certain information being sent~~  
12 ~~to the Selective Service Administration does not constitute grounds for denial of~~  
13 ~~a driver's license or identification card;~~ requiring the Motor Vehicle  
14 Administration to forward certain information to the Selective Service  
15 Administration in a certain manner; and generally relating to drivers' licenses  
16 and identification cards.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
23 MARYLAND, That the Laws of Maryland read as follows:

**Article - Transportation**

2 12-304.

3 (A) THIS SECTION APPLIES ONLY TO AN ADULT MALE APPLICANT UNDER THE  
4 AGE OF 26 YEARS.

5 (B) SUBJECT TO SUBSECTION (C) OF THIS SECTION, THE ADMINISTRATION  
6 SHALL PROVIDE TO THE SELECTIVE SERVICE ADMINISTRATION IN AN ELECTRONIC  
7 FORMAT, FOR PURPOSES OF REGISTRATION WITH THE SELECTIVE SERVICE AS  
8 REQUIRED UNDER FEDERAL LAW, THE NECESSARY INFORMATION CONCERNING A  
9 MALE APPLICANT WHO APPLIES FOR A DRIVER'S LICENSE OR IDENTIFICATION CARD  
10 OR THE RENEWAL OF A DRIVER'S LICENSE OR IDENTIFICATION CARD, INCLUDING  
11 THE APPLICANT'S:

12 (1) FULL NAME;

13 (2) CURRENT ADDRESS;

14 (3) DATE OF BIRTH;

15 (4) GENDER;

16 (5) DATE OF APPLICATION; AND

17 (6) SOCIAL SECURITY NUMBER, IF AVAILABLE.

18 (C) (1) A MALE APPLICANT'S SIGNATURE ON THE APPLICATION INDICATES  
19 THAT THE APPLICANT:

20 (I) HAS ALREADY REGISTERED WITH THE SELECTIVE SERVICE  
21 ADMINISTRATION; OR

22 (II) AUTHORIZES THE ADMINISTRATION TO FORWARD TO THE  
23 SELECTIVE SERVICE ADMINISTRATION THE NECESSARY INFORMATION FOR  
24 REGISTRATION.

25 (2) IN ADDITION TO THE INFORMATION REQUIRED UNDER THIS  
26 SUBTITLE OR TITLE 16 OF THIS ARTICLE, AN APPLICATION FORM FOR A DRIVER'S  
27 LICENSE OR IDENTIFICATION CARD OR RENEWAL OF A DRIVER'S LICENSE OR  
28 IDENTIFICATION CARD SHALL:

29 (⊕) CONTAIN A STATEMENT THAT A MALE APPLICANT'S  
30 SIGNATURE CONSTITUTES CONSENT TO FORWARDING THE INFORMATION IN

6     SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
7 October 1, 2002.
