- 6 regulatory authority of the Board; clarifying a certain inspection policy;

- 8 relate to the Board be performed on or before a certain date; requiring the Board
- 9 to submit a certain report by a certain date; and generally relating to the State

BE IT ENACTED BY THE GENERAL ASSEMBLY OF 3 4 MARYLAND, That the Laws of Maryland read as follows: 5 **Article - Health Occupations** 6 7-409. 7 All inspections of funeral establishments shall be unannounced AND MAY 8 TAKE PLACE AT ANY TIME WITHOUT NOTICE FROM THE BOARD. 9 (B) AN UNANNOUNCED INSPECTION MAY INCLUDE ADVANCE NOTICE THAT 10 AN INVESTIGATOR MAY BE IN THE REGION OF THE FUNERAL ESTABLISHMENT, IF: 11 (1) THE ADVANCE NOTICE IS NO MORE THAN 14 DAYS PRIOR TO THE 12 INSPECTION; 13 NO SPECIFIC DATE OR TIME IS PROVIDED FOR THE INSPECTION; AND (2) 14 THE ADVANCE NOTICE IS PROVIDED SOLELY TO ENSURE THAT A (3) 15 LICENSED MORTICIAN WILL BE ON-SITE FOR THE INSPECTION. 16 7-602. 17 Subject to the evaluation and reestablishment provisions of the Program 18 Evaluation Act, this title and all rules and regulations adopted under this title shall 19 terminate and be of no effect after July 1, [2002] 2012. 20 **Article - State Government** 21 8-403. 22 On or before December 15 of the 2nd year before the evaluation date of a governmental activity or unit, the Legislative Policy Committee, based on a 24 preliminary evaluation, may waive as unnecessary the evaluation required under this 25 section. 26 Except as otherwise provided in subsection (a) of this section, on or before (b) 27 the evaluation date for the following governmental activities or units, an evaluation 28 shall be made of the following governmental activities or units and the statutes and 29 regulations that relate to the governmental activities or units: 30 (41) Morticians, State Board of (§ 7-201 of the Health Occupations 31 Article: July 1, [2001] 2011);

SECTION 2. AND BE IT FURTHER ENACTED, That the State Board of 33 Morticians shall report to the General Assembly on or before October 1, 2002, in 34 accordance with § 2-1246 of the State Government Article, on the implementation

- 1 status of nonstatutory recommendations made by the Department of Legislative2 Services that are adopted by the Senate Education, Health, and Environmental
- 3 Affairs Committee and the House Environmental Matters Committee.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 5 July 1, 2002.
