CHAPTER _____

1 AN ACT concerning

2 **Alcoholic Beverages - Wholesaler's Licenses**

3 FOR the purpose of repealing a provision of law prohibiting two locations under one
4 wholesaler's license from being located in any one county or in Baltimore City.

5 BY repealing and reenacting, with amendments,
6 Article 2B - Alcoholic Beverages
7 Section 2-301(a)
8 Annotated Code of Maryland
9 (2001 Replacement Volume)

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
11 MARYLAND, That the Laws of Maryland read as follows:

12 **Article 2B - Alcoholic Beverages**

13 2-301.

14 (a) (1) The annual fees for the following classes of wholesaler's licenses are:

15	Class 1	Beer, wine and liquor.....	\$2,000
16	Class 2	Wine and liquor.....	1,750
17	Class 3	Beer and wine.....	1,500
18	Class 4	Beer	1,250

.....

1 Class 5 Wine 1,250

2 (2) Upon approval of the application:

3 (i) A Class 1 wholesale licensee may use additional locations for
4 the warehousing, sale and delivery of beer, wine and liquor upon the payment of an
5 additional fee of \$2,000 for each additional location.

6 (ii) A Class 2 wholesale licensee may use additional locations for
7 the warehousing, sale and delivery of wine and liquor upon the payment of an
8 additional fee of \$1,750 for each additional location.

9 (iii) A Class 3 wholesale licensee may use additional locations for
10 the warehousing, sale and delivery of beer and wine upon the payment of an
11 additional fee of \$1,500 for each additional location.

12 (iv) A Class 4 wholesale licensee may use additional locations for
13 the warehousing, sale and delivery of beer upon the payment of an additional fee of
14 \$1,250 for each additional location.

15 (v) A Class 5 wholesale licensee may use additional locations for
16 the warehousing, sale and delivery of wine upon the payment of an additional fee of
17 \$1,250 for each additional location.

18 [(3) Two locations under one license may not be located in any one county
19 or in Baltimore City.]

20 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
21 July 1, 2002.
