BE IT ENACTED BY THE GENERAL ASSEMBLY OF 3 MARYLAND, That the Laws of Maryland read as follows: 4 **Article - Health Occupations** 5 18-201. 6 There is a State Board of Examiners of Psychologists in the Department. 7 18-502. 8 Subject to the evaluation and reestablishment provisions of the Program 9 Evaluation Act, this title and all rules and regulations adopted under this title shall 10 terminate and be of no effect after July 1, [2003] 2013. 11 **Article - State Government** 12 8-403. On or before December 15 of the 2nd year before the evaluation date of a 13 14 governmental activity or unit, the Legislative Policy Committee, based on a 15 preliminary evaluation, may waive as unnecessary the evaluation required under this 16 section. 17 (b) Except as otherwise provided in subsection (a) of this section, on or before 18 the evaluation date for the following governmental activities or units, an evaluation 19 shall be made of the following governmental activities or units and the statutes and 20 regulations that relate to the governmental activities or units: 21 Psychologists, State Board of Examiners of (§ 18-201 of the Health (55)22 Occupations Article: July 1, [2002] 2012); 23 SECTION 2. AND BE IT FURTHER ENACTED, That the State Board of 24 Examiners of Psychologists shall report to the Senate Education, Health, and 25 Environmental Affairs Committee and the House Environmental Matters Committee, 26 on or before October 1, 2002, in accordance with § 2-1246 of the State Government 27 Article, on the implementation of the recommendations of the Department of 28 Legislative Services contained in the sunset evaluation report dated October 2001. 29 That report shall include a preliminary financial plan.
