A BILL ENTITLED

1 AN ACT concerning

2

Creation of a State Debt - Anne Arundel County - Indian King Tavern

3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$375,000,

4 the proceeds to be used as a grant to the Board of Directors of Historic

5 Annapolis, Inc. for certain development or improvement purposes; providing for

6 disbursement of the loan proceeds, subject to a requirement that the grantee

7 provide and expend a matching fund; requiring the grantee to grant and convey

8 a certain easement to Maryland Historical Trust; and providing generally for the

9 issuance and sale of bonds evidencing the loan.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 11 MARYLAND, That:

(1) The Board of Public Works may borrow money and incur indebtedness on
behalf of the State of Maryland through a State loan to be known as the Anne Arundel
County - Indian King Tavern Loan of 2002 in a total principal amount equal to the
lesser of (i) \$375,000 or (ii) the amount of the matching fund provided in accordance
with Section 1(5) below. This loan shall be evidenced by the issuance, sale, and
delivery of State general obligation bonds authorized by a resolution of the Board of
Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.

20 (2) The bonds to evidence this loan or installments of this loan may be sold as 21 a single issue or may be consolidated and sold as part of a single issue of bonds under 22 § 8-122 of the State Finance and Procurement Article.

(3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
and first shall be applied to the payment of the expenses of issuing, selling, and
delivering the bonds, unless funds for this purpose are otherwise provided, and then
shall be credited on the books of the Comptroller and expended, on approval by the
Board of Public Works, for the following public purposes, including any applicable
architects' and engineers' fees: as a grant to the Board of Directors of Historic
Annapolis, Inc. (referred to hereafter in this Act as "the grantee") for the repair and
renovation of the historic building known as Indian King Tavern, located at 10
Francis Street, Annapolis, to ensure the structural stability of the building so that it

32 can be developed as an educational facility for the public.

1 (4) An annual State tax is imposed on all assessable property in the State in

2 rate and amount sufficient to pay the principal of and interest on the bonds, as and

3 when due and until paid in full. The principal shall be discharged within 15 years 4 after the date of issuance of the bonds.

5 Prior to the payment of any funds under the provisions of this Act for the (5) 6 purposes set forth in Section 1(3) above, the grantee shall provide and expend a 7 matching fund. No part of the grantee's matching fund may be provided, either 8 directly or indirectly, from funds of the State, whether appropriated or 9 unappropriated. No part of the fund may consist of in kind contributions or funds 10 expended prior to the effective date of this Act. The fund may consist of real property. 11 In case of any dispute as to the amount of the matching fund or what money or assets 12 may qualify as matching funds, the Board of Public Works shall determine the matter 13 and the Board's decision is final. The grantee has until June 1, 2004, to present 14 evidence satisfactory to the Board of Public Works that a matching fund will be 15 provided. If satisfactory evidence is presented, the Board shall certify this fact and 16 the amount of the matching fund to the State Treasurer, and the proceeds of the loan 17 equal to the amount of the matching fund shall be expended for the purposes provided 18 in this Act. Any amount of the loan in excess of the amount of the matching fund 19 certified by the Board of Public Works shall be canceled and be of no further effect. Prior to the issuance of the bonds, the grantee shall grant and convey 20 (6)(a) 21 to the Maryland Historical Trust a perpetual preservation easement to the extent of 22 its interest:

23 (i) On the land or such portion of the land acceptable to the Trust;24 and

25(ii)On the exterior and interior, where appropriate, of the historic26 structures.

27 (b) If the grantee or beneficiary of the grant holds a lease on the land 28 and structures, the Trust may accept an easement on the leasehold interest.

29 (c) The easement must be in form and substance acceptable to the Trust 30 and any liens or encumbrances against the land or the structures must be acceptable 31 to the Trust.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 33 June 1, 2002.
