CHAPTER _____

1 AN ACT concerning

2 **Natural Resources - Wildlands - Savage Ravines and South Savage**

3 FOR the purpose of designating certain areas of the State as State Wildlands;
4 requiring the Department of Natural Resources to perform a certain survey by a
5 certain time; and generally relating to the wildlands named Savage Ravines and
6 South Savage.

7 BY adding to
8 Article - Natural Resources
9 Section 5-1203(aa) and (ff)
10 Annotated Code of Maryland
11 (2000 Replacement Volume and 2001 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Article - Natural Resources**

1 (II) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SUBTITLE,
2 THE DEPARTMENT MAY ALLOW RESEARCH STUDY IN THE SOUTH SAVAGE WILDLAND
3 AREA THAT INVOLVES SOME ACTIVITIES THAT ARE GENERALLY RESTRICTED OR
4 PROHIBITED IN STATE WILDLAND AREAS, IF THE DEPARTMENT DETERMINES THAT
5 THE ACTIVITIES WILL NOT CAUSE ADVERSE IMPACTS TO THE WILDLAND RESOURCES
6 AND THE ECOLOGICAL VALUES OF THE SITE.

7 (III) THE DEPARTMENT AND THE UNIVERSITY SYSTEM OF
8 MARYLAND, THROUGH ITS CONSTITUENT INSTITUTIONS FROSTBURG STATE
9 UNIVERSITY AND THE UNIVERSITY OF MARYLAND BIOTECHNOLOGY INSTITUTE,
10 SHALL DEVELOP A COMPREHENSIVE PLAN FOR THE SITE SETTING FORTH THE
11 TIMING, DURATION, AND GENERAL SCOPE OF THE RESEARCH ACTIVITIES TO BE
12 ALLOWED, SUBJECT TO PUBLIC REVIEW AND COMMENT AND SUBJECT TO APPROVAL
13 BY THE SECRETARY.

14 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
15 October 1, 2002.
