A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws - Air Bags - Improper or Fraudulent Replacement**

3 FOR the purpose of prohibiting a certain person who removes from a motor vehicle an
4 air bag or certain other inflatable vehicle passenger restraint system from
5 failing to replace the air bag or restraint system with certain equipment, or
6 replacing it with certain equipment that the person knows or has reason to
7 know is inoperable or will not operate as intended, is incompatible with or
8 inappropriate for the motor vehicle, or is not an air bag or certain other
9 inflatable vehicle passenger restraint system; establishing certain penalties;
10 and generally relating to the replacement of air bags or certain other inflatable
11 vehicle passenger restraint systems in certain motor vehicles under certain
12 circumstances.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That the Laws of Maryland read as follows:

20 **Article - Transportation**

21 22-419.

22 UNLESS THE PERSON IS THE OWNER OF THE MOTOR VEHICLE OR HAS THE
23 CONSENT OF THE OWNER, A PERSON WHO REMOVES FROM A MOTOR VEHICLE AN AIR
24 BAG OR OTHER INFLATABLE VEHICLE PASSENGER RESTRAINT SYSTEM DESIGNED IN
25 ACCORDANCE WITH FEDERAL SAFETY REGULATIONS AND ORIGINALLY INSTALLED
26 BY THE VEHICLE MANUFACTURER MAY NOT:

27 (1) FAIL TO REPLACE THE AIR BAG OR PASSENGER RESTRAINT SYSTEM
28 WITH AN AIR BAG OR OTHER INFLATABLE VEHICLE PASSENGER RESTRAINT SYSTEM

1 THAT IS DESIGNED AND INSTALLED IN ACCORDANCE WITH FEDERAL SAFETY
2 REGULATIONS FOR THAT VEHICLE; OR

3 (2) REPLACE THE AIR BAG OR PASSENGER RESTRAINT SYSTEM WITH:

4 (I) AN AIR BAG OR OTHER INFLATABLE VEHICLE PASSENGER
5 RESTRAINT SYSTEM THAT THE PERSON KNOWS OR HAS REASON TO KNOW IS
6 INOPERABLE OR WILL NOT OPERATE AS INTENDED;

7 (II) AN AIR BAG OR OTHER INFLATABLE VEHICLE PASSENGER
8 RESTRAINT SYSTEM DESIGNED IN ACCORDANCE WITH FEDERAL SAFETY
9 REGULATIONS THAT THE PERSON KNOWS OR HAS REASON TO KNOW IS
10 INCOMPATIBLE WITH OR INAPPROPRIATE FOR THAT VEHICLE; OR

11 (III) ANY OTHER OBJECT THAT THE PERSON KNOWS OR HAS
12 REASON TO KNOW IS NOT AN AIR BAG OR OTHER INFLATABLE VEHICLE PASSENGER
13 RESTRAINT SYSTEM DESIGNED IN ACCORDANCE WITH FEDERAL SAFETY
14 REGULATIONS.

16 (V) ANY PERSON WHO IS CONVICTED OF A VIOLATION OF § 22-419 OF THIS
17 ARTICLE IS SUBJECT TO A FINE OF NOT MORE THAN \$5,000 OR IMPRISONMENT FOR
18 NOT MORE THAN 1 YEAR OR BOTH.

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 October 1, 2002.
