A BILL ENTITLED

1 AN ACT concerning

2 Creation of a State Debt - Baltimore City - Chase Brexton Health Services

- 3 FOR the purpose of authorizing the creation of a State Debt not to exceed \$500,000,
- 4 the proceeds to be used as a grant to the Board of Directors of Chase Brexton
- 5 Health Services, Inc. for certain development, or improvement purposes;
- 6 providing for disbursement of the loan proceeds, subject to a requirement that
- 7 the grantee provide and expend a matching fund; requiring the grantee to grant
- 8 and convey a certain easement to the Maryland Historical Trust; and providing
- 9 generally for the issuance and sale of bonds evidencing the loan.

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

11 MARYLAND, That:

- 12 (1) The Board of Public Works may borrow money and incur indebtedness on
- 13 behalf of the State of Maryland through a State loan to be known as the Baltimore
- 14 City Chase Brexton Health Services, Inc. Loan of 2002 in a total principal amount
- 15 equal to the lesser of (i) \$500,000 or (ii) the amount of the matching fund provided in
- 16 accordance with Section 1(5) below. This loan shall be evidenced by the issuance, sale,
- 17 and delivery of State general obligation bonds authorized by a resolution of the Board
- 18 of Public Works and issued, sold, and delivered in accordance with §§ 8-117 through
- 19 8-124 of the State Finance and Procurement Article and Article 31, § 22 of the Code.
- 20 (2) The bonds to evidence this loan or installments of this loan may be sold as 21 a single issue or may be consolidated and sold as part of a single issue of bonds under
- 22 § 8-122 of the State Finance and Procurement Article.
- 23 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer
- 24 and first shall be applied to the payment of the expenses of issuing, selling, and
- 25 delivering the bonds, unless funds for this purpose are otherwise provided, and then
- 26 shall be credited on the books of the Comptroller and expended, on approval by the
- 27 Board of Public Works, for the following public purposes, including any applicable
- 28 architects' and engineers' fees: as a grant to the Board of Directors of Chase Brexton
- 29 Health Services, Inc. (referred to hereafter in this Act as "the grantee") for the
- 30 acquisition, renovation, design, construction, and capital equipping of a building to
- 31 increase operating space, to house expanded dental and mental health services, and

- 1 to provide space for administration and development offices located at 10 West Eager
 2 Street in the Mt. Vornen paickborhood of Politimera City.
- 2 Street in the Mt. Vernon neighborhood of Baltimore City.
- 3 (4) An annual State tax is imposed on all assessable property in the State in 4 rate and amount sufficient to pay the principal of and interest on the bonds, as and
- 5 when due and until paid in full. The principal shall be discharged within 15 years
- 6 after the date of issuance of the bonds.
- 7 (5) Prior to the payment of any funds under the provisions of this Act for the
- 8 purposes set forth in Section 1(3) above, the grantee shall provide and expend a
- 9 matching fund. No part of the grantee's matching fund may be provided, either
- 10 directly or indirectly, from funds of the State, whether appropriated or
- 11 unappropriated. No part of the fund may consist of real property, in kind
- 12 contributions, or funds expended prior to the effective date of this Act. In case of any
- 13 dispute as to the amount of the matching fund or what money or assets may qualify
- 14 as matching funds, the Board of Public Works shall determine the matter and the
- 15 Board's decision is final. The grantee has until June 1, 2004, to present evidence
- 16 satisfactory to the Board of Public Works that a matching fund will be provided. If
- 17 satisfactory evidence is presented, the Board shall certify this fact and the amount of
- 18 the matching fund to the State Treasurer, and the proceeds of the loan equal to the
- 19 amount of the matching fund shall be expended for the purposes provided in this Act.
- 20 Any amount of the loan in excess of the amount of the matching fund certified by the
- 21 Board of Public Works shall be canceled and be of no further effect.
- 22 (6) (a) Prior to the issuance of the bonds, the grantee shall grant and convey
- 23 to the Maryland Historical Trust a perpetual preservation easement to the extent of
- 24 its interest:
- 25 (i) On the land or such portion of the land acceptable to the Trust;
- 26 and
- 27 (ii) On the exterior and interior, where appropriate, of the historic
- 28 structures.
- 29 (b) The easement must be in form and substance acceptable to the Trust
- 30 and the extent of the interest to be encumbered must be acceptable to the Trust.
- 31 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 32 June 1, 2002.
