- 3 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 4 MARYLAND, That the Laws of Maryland read as follows:
- 5 Article Health General

- 7 (A) THERE IS A STATEWIDE ADVISORY COMMISSION ON IMMUNIZATIONS.
- 8 (B) THE COMMISSION CONSISTS OF AT LEAST THE FOLLOWING MEMBERS:
- 9 (1) ONE PHYSICIAN MEMBER OF THE MEDICAL AND CHIRURGICAL 10 FACULTY PUBLIC HEALTH COUNCIL;
- 11 (2) ONE PHYSICIAN MEMBER OF THE MARYLAND CHAPTER OF THE
- 12 AMERICAN ACADEMY OF PEDIATRICS WHO SPECIALIZES IN INFECTIOUS DISEASES;
- 13 ONE PHYSICIAN MEMBER OF THE MARYLAND CHAPTER OF THE
- 14 AMERICAN ACADEMY OF PEDIATRICS WITH EXPERIENCE IN PRIVATE PRACTICE;
- 15 (4) ONE PHYSICIAN MEMBER OF THE MARYLAND ACADEMY OF FAMILY
- 16 PHYSICIANS;
- 17 (5) ONE PHYSICIAN MEMBER OF THE AMERICAN COLLEGE OF

- 27 SPONSORED RECOMMENDATIONS FOR SKIPPED OR POSTPONED DOSAGES OF
- 28 VACCINES AND DEVELOP A FORM THAT SHALL BE USED BY SCHOOLS IN THE STATE;
- DEVELOP AND IMPLEMENT A UNIFORM PROCESS FOR SUSPENDING
- 30 SCHOOL ENTRY VACCINATION REOUIREMENTS WHEN VACCINE SHORTAGES DELAY
- 31 IMMUNIZATION OF CHILDREN:
- 32 DEVELOP A COMMUNICATIONS CAMPAIGN TO INFORM THE
- 33 GENERAL PUBLIC IN THE EVENT OF A VACCINE SHORTAGE; AND
- CREATE A PLAN FOR AN INFRASTRUCTURE THAT CAN EQUITABLY
- 35 DISTRIBUTE VACCINATIONS IN THE EVENT OF A BIOTERRORISM EMERGENCY.

SENATE BILL 788

- 1 (I) ON OR BEFORE DECEMBER 15 OF EACH YEAR, THE COMMISSION SHALL
- 2 SUBMIT A REPORT ON THE STATUS OF VACCINE SHORTAGES AND IMMUNIZATION
- 3 RATES IN THE STATE, TO THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1246 OF
- 4 THE STATE GOVERNMENT ARTICLE, TO THE SENATE EDUCATION, HEALTH, AND
- 5 ENVIRONMENTAL AFFAIRS COMMITTEE AND THE ENVIRONMENTAL MATTERS
- 6 COMMITTEE.

- 9 (a) (1) In cooperation with the State Board and the [Medical and
- 10 Chirurgical Faculty of Maryland] STATEWIDE ADVISORY COMMISSION ON
- 11 IMMUNIZATIONS, the Department of Health and Mental Hygiene shall adopt rules
- 12 and regulations regarding the immunizations and blood tests for lead poisoning
- 13 required of children entering schools.
- 14 SECTION 2. AND BE IT FURTHER ENACTED, That, on or before December
- 15 15, 2003, the Commission shall report on the Commission's recommendations
- 16 regarding the universal purchase of vaccine described in § 18-214(h)(1) of the Health
- 17 General Article, as enacted by Section 1 of this Act, to the Governor and, in
- 18 accordance with § 2-1246 of the State Government Article, to the Senate Education,
- 19 Health, and Environmental Affairs Committee and the Environmental Matters
- 20 Committee.
- 21 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 22 October 1, 2002.
