A BILL ENTITLED

1 AN ACT concerning

2 **Congressional Districting Plan of 2002**

3 FOR the purpose of establishing the composition of the eight districts in the State for
4 the election of members to the United States House of Representatives;
5 specifying certain ward, election district, and precinct boundaries; making this
6 Act an emergency Act; and generally relating to the reconfiguration of
7 congressional districts in the State.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
19 MARYLAND, That Section(s) 8-702 through 8-709 of Article 33 - Election Code of
20 the Annotated Code of Maryland be repealed.

21 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland
