- 7 apply to the salary or compensation of each judge of the Orphans' Court for Cecil
- 8 County and each judge of the Orphans' Court for Kent County in office on the effective
- 9 date of this Act, but the provisions of this Act concerning the salary or compensation
- 10 of each judge of the Orphans' Court for Cecil County and each judge of the Orphans'
- 11 Court for Kent County shall take effect at the beginning of the next following term of
