7 requiring certain members of the board be appointed from certain councilmanic

8 districts; establishing term limits for members of the board; prohibiting the

9 board from establishing a board of directors or delegating certain powers or

10 duties; requiring the board to meet at certain times; requiring that the Enoch

11 Pratt Free Library consist of certain branches; providing that the Enoch Pratt

12 Free Library is a public agency of Baltimore City and a State agency; providing

13 that this Act supersedes any contrary provisions of existing laws pertaining to

14 the Enoch Pratt Free Library; and generally relating to the Enoch Pratt Free

15 Library of Baltimore City.

5 (a) The Central Library of the Enoch Pratt Free Library System is the State 6 Library Resource Center.

7 (b) The State Library Resource Center shall provide and expand access to
8 specialized library materials and services that are necessary for coordinated,
9 efficient, and economical library services in this State.

11 (a) (1) [The] EXCEPT AS PROVIDED UNDER SUBSECTIONS (F), (G), AND (H)

14 Baltimore City as provided in Chapter 181 of the Acts of 1882 and any other laws

35 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial

36 members of the Board of Trustees of the Enoch Pratt Free Library shall expire as 37 follows:

- 1 (1) One member in 2003;
- 2 (2) Two members in 2004;
- 3 (3) Two members in 2005;
- 4 (4) Two members in 2006; and
- 5 (5) Two members in 2007.

6 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall supersede 7 any contrary provisions of existing laws pertaining to the Enoch Pratt Free Library of 8 Baltimore City.

9 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect 10 July 1, 2002.
