SENATE JOINT RESOLUTION

American Indian Heritage Month

- 1 A Senate Joint Resolution concerning
- 3 FOR the purpose of designating November as "American Indian Heritage Month".
- WHEREAS, Maryland is inextricably linked to the histories of the American
- 5 Indians with reminders of their legacy speaking to Marylanders through the names of
- 6 its counties, parks, and waterways including, Wicomico County, Allegany County,
- 7 Seneca State Park, the Potomac River, and the Chesapeake Bay, the Nation's largest
- 8 estuary, that derives its name from the Powhatan Indian word "Chesepiooc" meaning
- 9 "Great Shellfish Bay"; and
- 10 WHEREAS, American Indian societies exhibited a respect for the finite quality
- 11 of natural resources through a deep respect for the Earth, and such values continue to
- 12 be widely held today; and
- WHEREAS, The people of Maryland should be reminded of the assistance given
- 14 to the early European visitors to North America by the ancestors of today's American
- 15 Indians, including knowledge and training provided to the Pilgrims in survival
- 16 hunting and cultivation and fertilization of indigenous crops; and
- 17 WHEREAS, American Indian people have served with valor in all wars that the
- 18 United States has engaged in, from the Revolutionary War to the conflict in the
- 19 Persian Gulf, often serving in greater numbers, proportionately, than the population
- 20 of the Nation as a whole; and
- 21 WHEREAS, In recognizing the many contributions made by the American
- 22 Indians to the United States, Presidents Carter, Reagan, Bush Sr., and Clinton have
- 23 all issued national proclamations during their administrations declaring the month of
- 24 November as "American Indian Heritage Month"; and
- 25 WHEREAS, The Members of the Senate and House of Delegates believe that a
- 26 resolution and proclamation of the nature requested in this resolution can encourage
- 27 activities which provide positive benefits of enhanced self-esteem, pride, and
- 28 self-awareness to young American Indians; and

- WHEREAS, November is a time when many Marylanders commemorate a
- 2 special time in the history of the United States when American Indians and English
- 3 settlers celebrated the bounty of their harvest and the promise of new kinships; and
- 4 WHEREAS, The month of November concludes the traditional harvest season of
- 5 American Indians and was generally a time of celebration and giving thanks; now,
- 6 therefore, be it
- 7 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That the month
- 8 of November is designated as "American Indian Heritage Month"; and be it further
- 9 RESOLVED, That schools, libraries, State and local governments, and other
- 10 organizations within the State should appropriately observe this month; and be it
- 11 further
- 12 RESOLVED, That State and local governments will use the month of November
- 13 to assess the ways to improve understanding, cooperation, and communication with
- 14 American Indians, especially those residing within Maryland's borders; and be it
- 15 further
- 16 RESOLVED, That a copy of this Resolution be forwarded by the Department of
- 17 Legislative Services to the Honorable Parris N. Glendening, Governor of Maryland;
- 18 the Honorable Thomas V. Mike Miller, Jr., President of the Senate of Maryland; and
- 19 the Honorable Casper R. Taylor, Jr., Speaker of the House of Delegates.
