## **Public Schools - Character Education Program**

3 FOR the purpose of urging each county board of education to develop a character

4 education program to be taught in its schools that includes discussion of certain

5 character traits; and generally relating to a character education program in

6 public schools.

7 WHEREAS, Teaching students civic virtues and the importance of good
8 character improves a school's learning environment, promotes student achievement,
9 reduces disciplinary problems, and develops civic-minded students of high character;
10 and

11 WHEREAS, A character education program developed in cooperation with each 12 county board of education, individual schools, students, parents, and the community 13 may be more effective and accepted; now, therefore, be it

14 RESOLVED BY THE GENERAL ASSEMBLY OF MARYLAND, That each 15 county board of education is strongly encouraged to develop a character education 16 program in its schools that includes discussion of the following character traits:

17 (1) Trustworthiness, including honesty, integrity, reliability, and loyalty;

18 (2) Respect, including tolerance, courtesy, and the principles of the Golden19 Rule;

20 (3) Responsibility, including hard work, economic self-reliance, accountability, 21 diligence, perseverance, and self-control;

1 (4) Fairness, including justice, consequences of bad behavior, principles of 2 nondiscrimination, and freedom from prejudice;

3 (5) Caring, including kindness, empathy, compassion, consideration, 4 generosity, and charity; and

5 (6) Citizenship, including patriotism, the pledge of allegiance, respect for the 6 American flag, concern for the common good, respect for authority and the law, and 7 community-mindedness; and be it further

8 RESOLVED, That a copy of this Resolution be forwarded by the Department of 9 Legislative Services to the Honorable Parris N. Glendening, Governor of Maryland; 10 the Honorable Thomas V.
