St. Mary's County - Public Officials - Salaries

This bill increases the annual salaries of officials in St. Mary's County, as follows:

Fiscal Summary

State Effect: None.

Local Effect: St. Mary's County expenditures would increase by \$36,400 in FY 2003 and by \$72,800 in FY 2004 and each year thereafter. Revenues would not be affected.

Small Business Effect: None.

Analysis

Current Law: Salary adjustments for constitutional officers take effect at the beginning of the next term of office. In St. Mary's County, the term of office for county commissioners are not staggered, accordingly all five members will begin a new term in

January 2003. The Sheriff, the County Treasurer, and the Orphans' Court judges all begin new terms in January 2003.

Background: The salaries of the County Commissioners were last changed in 1994 (Chapter 181 of 1990) when the salary for the president was established at \$27,000 and the salaries of the other commissioners were set at \$21,000. The salaries of the Sheriff, County Treasurer, and Orphans' Court judges were last changed in 1999 (Chapter 316 of 1998). The salary of the Sheriff was increased from \$48,000 to \$50,000, the salary of the County Treasurer was increased from \$29,000 to \$36,000, and the salaries of the three Orphans' Court judges were increased from \$2,400 to \$3,000.

Local Fiscal Effect: St. Mary's County expenditures would increase by \$36,400 in fiscal 2003 which accounts for additional salary (\$28,000) and fringe benefits (\$8,400). This reflects salary adjustments for a six-month period (January 2003 -- June 2003). Beginning in fiscal 2004, county expenditures would increase by \$72,800 which reflects annualization. **Exhibit 1** shows the fiscal impact by position.
