Caroline County - State's Attorney - Salary

This bill sets the salary of the State's Attorney of Caroline County at 80% of the salary of a judge of the District Court of Maryland beginning with the next term of office in January 2003.

Fiscal Summary

State Effect: State retirement expenditures would increase by \$550 in FY 2003 and by \$1,100 in FY 2004 and each year thereafter.

Local Effect: Caroline County expenditures would increase by \$12,500 in FY 2003 and by \$25,000 in FY 2004 and each year thereafter.

Small Business Effect: None.

Analysis

Current Law: The current salary of the State's Attorney of Caroline County is \$70,000. Salary adjustments for constitutional officers take effect at the beginning of the next term of office, which begins January 2003 for the Caroline County State's Attorney.

Background: The salary of the State's Attorney of Caroline County was last changed in 1995 (Chapter 397 of 1994) when the salary was increased from \$55,000 to \$70,000. Salaries of State's Attorneys in 15 counties are tied to the salaries of judges. As shown in **Exhibit 1**, the salaries are tied to District Court judges in 13 counties and to circuit court judges in two counties.

^{*} In Allegany County, the deputy State's Attorneys must receive not less than 80% of the salary of the State's Attorney.

District Court Judges Salary

The salary for a District Court judge is currently set at \$111,500.

State Fiscal Effect: The State is responsible for making the retirement contributions for the State's Attorney of Caroline County. Based on the State's fiscal 2003 contribution rate of 5.74% of salary, expenditures would increase by \$551 in fiscal 2003, which reflects the State's contribution for the six months of fiscal 2003 after the new term of office begins. Future expenditures would increase by \$1,100 in fiscal 2004 and each year thereafter.

^{**}In Anne Arundel County, the deputy State's Attorneys must receive not less than 90% of the salary of the State's Attorneys must receive not less than 80% of the State's Attorney's salary.

Local Fiscal Effect: The salary of the Caroline County State's Attorney would increase from \$70,000 to \$89,200 beginning in January 2003.

Caroline County expenditures would increase by \$12,480 in fiscal 2003 for additional salary (\$9,600) and fringe benefits (\$2,880). This reflects salary adjustments for a sixmonth period (January 2003 – June 2003). Beginning in fiscal 2004, county expenditures would increase by \$24,960, which reflects annualization.
