AMENDMENT NO. 2

On page 2, in line 26, after "<u>(C)</u>" insert "<u>(1) THIS SUBSECTION APPLIES TO THE</u> FOLLOWING INDIVIDUALS:

(I) <u>AN ACTIVE DUTY MEMBER OF THE UNITED STATES ARMED</u>

FORCES;

(II) <u>A DEPENDANT OF AN ACTIVE DUTY MEMBER OF THE</u> <u>UNITED STATES ARMED FORCES; AND</u>

(III) <u>AN HONORABLY DISCHARGED VETERAN OF THE UNITED</u> <u>STATES ARMED FORCES.</u>

(2) NOTWITHSTANDING ANY OTHER PROVISION OF THIS ARTICLE AND SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION, AN INDIVIDUAL DESCRIBED IN PARAGRAPH (1) OF THIS SUBSECTION IS EXEMPT FROM PAYING NONRESIDENT TUITION AT A PUBLIC INSTITUTION OF HIGHER EDUCATION IF THE INDIVIDUAL PRODUCES THE FOLLOWING DOCUMENTATION:

(I) EVIDENCE OF THE INDIVIDUAL'S DOMICILE IN THIS STATE;

<u>AND</u>

(II) ONE OF THE FOLLOWING TYPES OF EVIDENCE OF ACTIVE DUTY, HONORABLE DISCHARGE, OR MILITARY DEPENDANT STATUS:

<u>1.</u> <u>A COPY OF THE INDIVIDUAL'S DD214;</u>

2. <u>A VALID MILITARY IDENTIFICATION CARD OR VALID</u> <u>MILITARY DEPENDANT IDENTIFICATION CARD; OR</u>

3. <u>A COPY OF THE DEPENDANT DATA SHEET FROM THE</u> <u>MEMBER'S MILITARY SERVICE RECORD.</u>

(3) TO QUALIFY FOR RESIDENT TUITION CHARGES, AN HONORABLY DISCHARGED VETERAN OF THE UNITED STATES ARMED FORCES SHALL PRESENT THE DOCUMENTATION REQUIRED UNDER PARAGRAPH (2) OF THIS SUBSECTION WITHIN 1 YEAR AFTER THE VETERAN'S DISCHARGE.

(4) AN HONORABLY DISCHARGED VETERAN WHO QUALIFIES FOR RESIDENT TUITION CHARGES UNDER THIS SUBSECTION SHALL REMAIN QUALIFIED UNTIL COMPLETION OF THE VETERAN'S ACADEMIC PROGRAM.
