#### AMENDMENT NO. 1

On page 1, in line 3, after "Checks" insert "and Background Investigations"; strike beginning with "from" in line 5 down through the second "agencies" in line 6 and substitute "or background investigations"; in line 7, after the first "County" insert "under certain circumstances"; strike beginning with "either" in line 8 down through "or" in line 9 and substitute "to an"; in line 9, strike the second "agencies" and substitute "agency under certain circumstances"; in line 10, after "regulations;" insert "defining a certain term;"; and in line 11, after "checks" insert "and background investigations".

#### AMENDMENT NO. 2

On page 1, after line 21, insert:

"(A) IN THIS SECTION, "CENTRAL REPOSITORY" MEANS THE CRIMINAL JUSTICE INFORMATION SYSTEM CENTRAL REPOSITORY OF THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES.";

in lines 22 and 28, in each instance, strike "(A)" and substitute "(B)"; in line 22, after "REQUEST" insert "WITH REFERENCE TO A PROSPECTIVE EMPLOYEE OF WASHINGTON COUNTY:

in line 24, strike "OR THROUGH" and substitute "; OR

#### (2) A BACKGROUND INVESTIGATION FROM";

strike beginning with "FOR" in line 24 down through "COUNTY" in line 25; after line 25, insert:

"(C) (1) AS PART OF THE APPLICATION FOR A CRIMINAL HISTORY

RECORDS CHECK, THE COUNTY ADMINISTRATOR OF WASHINGTON COUNTY SHALL SUBMIT TO THE CENTRAL REPOSITORY:

- (I) TWO COMPLETE SETS OF THE PROSPECTIVE EMPLOYEE'S LEGIBLE FINGERPRINTS TAKEN ON FORMS APPROVED BY THE DIRECTOR OF THE CENTRAL REPOSITORY AND THE DIRECTOR OF THE FEDERAL BUREAU OF INVESTIGATION;
- (II) THE FEE AUTHORIZED UNDER § 10-221(B)(7) OF THE CRIMINAL PROCEDURE ARTICLE FOR ACCESS TO MARYLAND CRIMINAL HISTORY RECORDS; AND
- (III) THE MANDATORY PROCESSING FEE REQUIRED BY THE FEDERAL BUREAU OF INVESTIGATION FOR A NATIONAL CRIMINAL HISTORY RECORDS CHECK.
- (2) IN ACCORDANCE WITH §§ 10-201 THROUGH 10-234 OF THE CRIMINAL PROCEDURE ARTICLE, THE CENTRAL REPOSITORY SHALL FORWARD TO THE PROSPECTIVE EMPLOYEE AND THE COUNTY ADMINISTRATOR OF WASHINGTON COUNTY THE PROSPECTIVE EMPLOYEE'S CRIMINAL HISTORY RECORD INFORMATION.
- (3) <u>INFORMATION OBTAINED FROM THE CENTRAL REPOSITORY</u> <u>UNDER THIS SECTION:</u>
- (I) IS CONFIDENTIAL AND MAY NOT BE REDISSEMINATED;
  AND

- (4) THE SUBJECT OF A CRIMINAL HISTORY RECORDS CHECK UNDER THIS SECTION MAY CONTEST THE CONTENTS OF THE PRINTED STATEMENT ISSUED BY THE CENTRAL REPOSITORY AS PROVIDED IN § 10-223 OF THE CRIMINAL PROCEDURE ARTICLE.";
