- (5) <u>IMMEDIATELY UPON CEASING TO PROVIDE SERVICES</u> EXCLUSIVELY IN THE MANNER DESCRIBED IN § 4-308(C), SURRENDER THE

VOLUNTEER LICENSE TO THE BOARD.

- (L) IN ADDITION TO THE REQUIREMENTS OF SUBSECTIONS (A), (B), (C), AND (E) OF THIS SECTION, TO QUALIFY FOR A VOLUNTEER DENTAL HYGIENIST'S LICENSE TO PRACTICE DENTAL HYGIENE, AN APPLICANT SHALL:
- (1) SATISFY THE REQUIREMENTS OF § 4-306(B)(2) AND (E)(2) OF THIS SUBTITLE;
- (2) HOLD AN ACTIVE LICENSE TO PRACTICE DENTAL HYGIENE IN ANOTHER STATE OR IN THE DISTRICT OF COLUMBIA;

- (4) PROVIDE DENTAL HYGIENE SERVICES EXCLUSIVELY IN THE MANNER DESCRIBED IN § 4-308(F) OF THIS SUBTITLE; AND
- (5) <u>IMMEDIATELY UPON CEASING TO PROVIDE SERVICES</u>

in lines 8, 13, and 19, in each instance, strike the bracket; in lines 8 and 19, in each instance, after "license" insert "OR A VOLUNTEER DENTIST'S LICENSE"; and in line 13, after "license" insert "OR A VOLUNTEER DENTAL HYGIENIST'S LICENSE".

On page 5, in line 2, in each instance, strike the bracket; and in line 2, after "license" insert "OR A VOLUNTEER DENTAL HYGIENIST'S LICENSE".

AMENDMENT NO. 4

On page 5, in lines 1 and 19, in each instance, after "profit" insert "<u>IN MARYLAND</u>"; and in line 21, after "2003" insert "<u>contingent on the taking effect of Chapter</u> (S.B. 414/H.B. 334) of the Acts of the General Assembly of 2003, and if Chapter does not become effective, this Act shall be
