AMENDMENTS TO HOUSE BILL NO. 1082 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, strike line 2 in its entirety and substitute "<u>Homeland Security - Protection of</u> <u>Building Records</u>"; and in line 6, after "facilities;" insert "<u>providing that a custodian may not deny</u> <u>inspection of certain records relating to certain buildings, building inspections, and citations;</u>".

AMENDMENT NO. 2

On page 1, in line 26, strike "paragraph (2)" and substitute "<u>PARAGRAPHS (2), (3), AND</u> (4)".

On page 2, in line 7, strike the first "and"; in the same line, after "systems," insert "<u>AND</u> <u>ANY OTHER BUILDING, STRUCTURE, OR FACILITY</u>,"; and after line 27, insert:

"(<u>3</u> (<u>I</u>) <u>SUBJECT TO SUBPARAGRAPH (II) OF THIS PARAGRAPH, A</u> <u>CUSTODIAN MAY NOT DENY INSPECTION OF A PUBLIC RECORD UNDER PARAGRAPH</u> (<u>1</u>) OR (<u>2</u>) OF THIS SUBSECTION THAT RELATES TO A BUILDING, STRUCTURE, OR <u>FACILITY THAT HAS BEEN SUBJECTED TO A CATASTROPHIC EVENT, INCLUDING TO</u> <u>A FIRE, EXPLOSION, OR NATURAL DISASTER.</u>

(II) THIS PARAGRAPH DOES NOT APPLY TO THE RECORDS OF ANY BUILDING, STRUCTURE, OR FACILITY OWNED OR OPERATED BY THE STATE OR ANY OF ITS POLITICAL SUBDIVISIONS.

(4) (I) SUBJECT TO PARAGRAPHS (1) AND (2) OF THIS SUBSECTION AND SUBPARAGRAPH (II) OF THIS PARAGRAPH, A CUSTODIAN MAY NOT DENY INSPECTION OF A PUBLIC RECORD THAT RELATES TO AN INSPECTION OF OR ISSUANCE OF A CITATION CONCERNING A BUILDING, STRUCTURE, OR FACILITY BY AN AGENCY OF THE STATE OR ANY POLITICAL SUBDIVISION.
