AMENDMENT NO. 2

(1) CURRICULUM COURSES OR SEMINARS OFFERED OR REQUIRED BY INSTITUTIONS OF HIGHER EDUCATION;

- (3) CONTINUING EDUCATION PROGRAMS OFFERED BY HOSPITALS FOR HOSPITAL STAFF AND HEALTH CARE PRACTITIONERS.

in line 6, strike "(1)"; in line 8, strike "SHALL" and substitute "MAY"; in lines 12 and 15, strike "(I)" and "(II)", respectively, and substitute "(1)" and "(2)", respectively; in line 16, strike "(2)" and substitute "(B)"; in the same line, strike "REQUIRED" and substitute "DESCRIBED"; in line 17, strike "PARAGRAPH (1) OF THIS SUBSECTION" and substitute "SUBSECTION (A) OF THIS SECTION"; and in lines 20, 21, 22, and 23, strike "(I)", "(III)", and "(IV)", respectively, and substitute "(1)", "(2)", "(3)", and "(4)", respectively.

On pages 3 and 4, strike in their entirety the lines beginning with line 24 on page 3 through line 6 on page 4, inclusive.

On page 4, after line 6, insert:

- (E) BY SEPTEMBER 30, 2004, THE DEPARTMENT AND THE ENTITIES LISTED IN SUBSECTION (B) OF THIS SECTION SHALL:
- (1) (I) EXAMINE CURRENT CONTINUING EDUCATION PROGRAMS OFFERED BY HOSPITALS AND PHYSICIAN ORGANIZATIONS IN THE STATE THAT ARE

strike in their entirety lines 27 through 29, inclusive; in line 30, strike "(D)" and substitute "<u>(F)</u>"; in line 31, after the comma, insert "<u>THE SENATE EDUCATION, HEALTH, AND ENVIRONMENTAL AFFAIRS COMMITTEE AND</u>"; and strike line 33 in its entirety and substitute "<u>THE DEVELOPMENT AND IMPLEMENTATION OF THE PLAN TO REDUCE HEALTH CARE DISPARITIES.</u>".

On page 5, strike in their entirety lines 1 through 12, inclusive; in line 13, strike "2." and substitute "3."; in line 24, strike "and" and substitute a comma; in the same line, after "sensitivity" insert ", and health literacy"; in line 34, strike the second "and"; and in line 37, after "standards" insert "; and

(6) identification of existing diabetes programs that have demonstrated success in the education, prevention, and treatment of diabetes with quantifiable standards".

AMENDMENT NO. 3

On page 5, in line 38, strike "3." and substitute "4."; in line 39, after "2003." insert "Section
