AMENDMENTS TO HOUSE BILL NO. 664

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 3, strike “Penalty” and substitute “Penalties”; and strike beginning with “altering” in line 4 down through “evidence;” in line 10.

AMENDMENT NO. 2

On page 1, after line 16, insert:

“BY repealing and reenacting, without amendments,

Article - Transportation

Section 16-303 and 16-402(a)(11)

Annotated Code of Maryland

(2002 Replacement Volume)”.

AMENDMENT NO. 3

On page 1, in line 19, strike “16-303,”; in the same line, strike “and (4)”;

in line 24, strike “16-402(a)(11) and (30)” and substitute “16-402(a)(30)”; and after line 26, insert:

“BY renumbering

Article - Transportation

Section 16-402(a)(24) through (29), respectively

to be Section 16-402(a)(25) through (30), respectively

Annotated Code of Maryland

(2002 Replacement Volume)”.

On page 2, in line 5, after “27-101(w)” insert “and 16-402(a)(24)”; strike in their entirety lines 8 through 13, inclusive; and in line 15, after “That” insert “Section(s) 16-402(a)(24) through (29), respectively, of Article - Transportation of the Annotated Code of Maryland be renumbered to

be Section(s) 16-402(a)(25) through (30), respectively.

SECTION 2. AND BE IT FURTHER ENACTED, That”.

AMENDMENT NO. 4

On page 2, in line 20, strike the brackets; strike beginning with “, SUSPENDED” in line 20 down through “STATE” in line 21; in lines 22, 31, and 34, in each instance, strike the bracket; in line 33, strike “REFUSED, SUSPENDED,”; and in the same line, strike “, OR REVOKED”.

On page 3, in line 22, strike the bracket.

AMENDMENT NO. 5

On page 3, strike in their entirety lines 23 through 37, inclusive.

AMENDMENT NO. 6

On page 4, in lines 6 and 8, in each instance, strike the bracket; and after line 8, insert:

“(24) DRIVING AFTER REFUSAL, SUSPENSION, CANCELLATION, OR REVOCATION OF LICENSE EXCEPT FOR SUSPENSIONS OF LICENSE UNDER THE PROVISIONS OF § 17-106, § 26-204, § 26-206, OR § 27-103 OF THIS ARTICLE, OR THE TRAFFIC LAWS OR REGULATIONS OF ANOTHER STATE AS DESCRIBED IN § 16-303(I) OF THIS TITLE .....6 POINTS”.

AMENDMENT NO. 7

On page 4, in line 16, strike “§ 16-402(A)(23)” and substitute “§ 16-402(A)(25)”; and in line 29, strike “§ 16-402(A)(23) OR (31)” and substitute “§ 16-402(A)(25) OR (33)”.

On page 5, strike in their entirety lines 1 through 14, inclusive.

AMENDMENT NO. 8

On page 7, in lines 3 and 15, strike “2.” and “3.”, respectively, and substitute “3.” and “4.”, respectively; strike in their entirety lines 28 through 31, inclusive; and in lines 32 and 35, strike “3” and “2”, respectively, and substitute “4” and “3”, respectively.
