AMENDMENTS TO SENATE BILL NO. 524

(First Reading File Bill)

AMENDMENT NO. 1

On page 2, after line 30, insert:

“(IV) ESTABLISH PROCEDURES FOR THE ORDERLY TRANSITION FROM AN EXISTING PRIVATE CONTRACTOR TO THE PRIVATE CONTRACTOR SELECTED TO CONTINUE PRIVATIZATION UNDER THIS SECTION;”;

and in line 31, strike “(IV)” and substitute “(V)”.

On page 3, in lines 6 and 9, strike “(V)” and “(VI)”, respectively, and substitute “(VI)” and “(VII)”, respectively; and in line 8, strike “(IV)” and substitute “(V)”.

AMENDMENT NO. 2

On page 2, in line 20, strike “(H)” and substitute “(I)”;

 and in line 33, strike “FORMER” and substitute “EXISTING”.

On page 3, after line 13, insert:

“(E) A STATE EMPLOYEE WHO IS A NONTEMPORARY EMPLOYEE WITH THE CHILD SUPPORT ENFORCEMENT ADMINISTRATION AND WHO IS CURRENTLY WORKING FOR THE EXISTING PRIVATE CONTRACTOR SHALL REMAIN A NONTEMPORARY EMPLOYEE WITH THE ADMINISTRATION FOR THE DURATION OF CHAPTER ____ (S.B. 524) OF THE ACTS OF THE GENERAL ASSEMBLY OF 2003, UNLESS THE EMPLOYEE ACCEPTS EMPLOYMENT WITH THE PRIVATE CONTRACTOR AS PROVIDED UNDER SUBSECTION (D)(1)(IV) OF THIS SECTION.”;

and in lines 14, 21, 32, and 34, strike “(E)”, “(F)”, “(G)”, and “(H)”, respectively, and substitute

(Over)

“(F)”, “(G)”, “(H)”, and “(I)”, respectively.

On page 4, in lines 1 and 3, strike “(I)” and “(J)”, respectively, and substitute “(J)” and “(K)”, respectively; and in line 1, strike “(J)” and substitute “(K)”.

AMENDMENT NO. 3

On page 5, in line 25, strike “TO THE ADMINISTRATION” and substitute “IN ACCORDANCE WITH § 10-115 OF THIS SUBTITLE”.

AMENDMENT NO. 4

On page 6, in line 34, strike “3 years” and substitute “4 years and 3 months”; in line 37, strike “5 years and 1 month” and substitute “6 years and 4 months”; and in line 38, strike “June 30, 2008” and substitute “September 30, 2009”.
