On page 16, in lines 4 and 5, in each instance, strike "INDIVIDUAL" and substitute "<u>PERSON</u>"; in lines 5 and 8, strike "(H)" and "(I)", respectively, and substitute "<u>(F)</u>" and "<u>(G)</u>", respectively; in lines 11 and 21, strike "8-6B-19." and "8-6B-20.", respectively, and substitute "<u>8-6B-20.</u>" and "<u>8-6B-21.</u>", respectively; in lines 12 and 29, in each instance, strike "§ 8-6B-18" and
