AMENDMENT NO. 1

On page 1, in line 2, strike "Unpossessed Vacant" and substitute "<u>Abandoned</u>"; in the same line, after "Land" insert "<u>- Certificate of Reservation for Public Use</u>"; in lines 3, 7, 21, 26 and 27, and 27 and 28, in each instance, strike "unpossessed vacant" and substitute "<u>abandoned</u>"; in line 7, after "claims" insert "<u>legal</u>"; in line 9, after "claim" insert "<u>under certain circumstances</u>"; in line 11, strike "mail" and substitute "<u>make</u>"; in line 13, strike "any action" and substitute "<u>certain actions</u>"; in the same line, strike "pursuant to" and substitute "<u>under</u>"; in line 14, strike "is" and substitute "<u>are</u>"; and in line 28, after "land" insert "and certificates of reservation for public use".

AMENDMENT NO. 2

On page 3, in line 6, after "land" insert "<u>OR ABANDONED LAND</u>"; and in line 19 after "land" insert "<u>AND ABANDONED LAND</u>".

On page 4, in line 7, strike "UNPOSSESSED VACANT" and substitute "<u>ABANDONED</u>"; and in lines 21 and 26, in each instance, after "land" insert "<u>OR ABANDONED LAND</u>".

On page 5 in lines 9 and 20, on page 6 in line 27, and on page 8 in line 4, in each instance, strike "UNPOSSESSED VACANT" and substitute "ABANDONED".

On page 5, in line 26, strike "EITHER"; and in line 31, strike "PURSUANT TO" and substitute "UNDER".

On page 8, in line 4, strike "PURSUANT TO" and substitute "UNDER".

AMENDMENT NO. 3

On page 4, in lines 8 and 9, strike "OR PARK FOR WHICH A PATENT MAY HAVE BEEN ISSUED BUT WHICH" and substitute ":

(1) FOR WHICH NO PROPERTY TAX PAYMENT HAS BEEN MADE WITHIN 20 YEARS IMMEDIATELY PRECEDING THE DATE OF AN APPLICATION FOR A CERTIFICATE OF RESERVATION FOR PUBLIC USE BY A UNIT OF STATE GOVERNMENT; AND

(2) WHICH".

AMENDMENT NO. 4

On page 5, in line 19, after "CLAIMS" insert "<u>LEGAL</u>"; in line 22, after "(B)" insert "<u>IF ABANDONED LAND WAS PATENTED PRIOR TO THE ISSUANCE OF A CERTIFICATE OF RESERVATION FOR PUBLIC USE BY A UNIT OF STATE GOVERNMENT,</u>"; and in the same line, after "CLAIM" insert "<u>FOR LEGAL TITLE TO THE LAND</u>".

AMENDMENT NO. 5

On page 2, strike in their entirety lines 17 and 18; in line 20, strike "the State forest and parks, particularly"; and in lines 25 and 26, strike "a State forest or park" and substitute "<u>Green Ridge State Forest</u>".

On page 4, in line 8, strike "A" and substitute "GREEN RIDGE".
