On page 1, in the sponsor line, strike "Delegate Hubbard" and substitute "<u>Delegates Hubbard</u>, <u>Hurson</u>, <u>Hammen</u>, <u>Benson</u>, <u>Boutin</u>, <u>Bromwell</u>, <u>Costa</u>, <u>Donoghue</u>, <u>Elliott</u>, <u>Goldwater</u>, <u>Haynes</u>, <u>Kach</u>, <u>Mandel</u>, <u>McDonough</u>, <u>Morhaim</u>, <u>Murray</u>, <u>Nathan-Pulliam</u>, <u>Oaks</u>, <u>Pendergrass</u>, <u>Rosenberg</u>, <u>Rudolph</u>, <u>Smigiel</u>, <u>and Weldon</u>"; strike beginning with "and" in line 2 down through "Hygiene" in line 3; strike beginning with "and" in line 4 down through "Hygiene" in line 5; strike beginning with "in" in line 6 down through "investigations" in line 8; in line 9, strike "and Department"; strike beginning with "fully" in line 9 down through "person" in line 10 and substitute "<u>make certain deficiencies</u>, <u>findings</u>, or <u>conclusions</u> of a <u>complaint investigation available to certain individuals</u>"; in line 12, strike "and Department"; and in line 15, strike "and 19-309".

AMENDMENT NO. 2

On page 1, in line 27, after the semicolon insert "AND".

On page 2, strike in their entirety lines 1 through 4, inclusive; in line 5, strike "(4)" and substitute "(2)"; and in the same line, after "NECESSARY" insert ", INCLUDING DURING:

(I) AN INVESTIGATION INTO A DEATH REPORTED IN ACCORDANCE WITH § 7-207 OF THIS TITLE; AND

(II) AN INVESTIGATION INTO AN INCIDENT REPORT RECEIVED BY THE ADMINISTRATION OR ITS DESIGNEE";

and in line 6, strike "(1)".

AMENDMENT NO. 3

On page 2, strike in their entirety lines 7 through 17, inclusive, and substitute:

- "(D) THE ADMINISTRATION, ON REQUEST, SHALL MAKE ANY DEFICIENCIES, FINDINGS, OR CONCLUSIONS OF A COMPLAINT INVESTIGATION AVAILABLE TO:
 - (1) THE INDIVIDUAL WITH DEVELOPMENTAL DISABILITY, IF:
- (I) A PERSON IS NOT AUTHORIZED TO ACT ON BEHALF OF THE INDIVIDUAL WITH DEVELOPMENTAL DISABILITY; AND
- WOULD NOT BE DETRIMENTAL TO THE INDIVIDUAL WITH DEVELOPMENTAL DISABILITY;
- (2) A PARENT OR GUARDIAN OF THE INDIVIDUAL WITH DEVELOPMENTAL DISABILITY WHO IS:
 - (I) A MINOR; OR
- (II) UNLESS THE INDIVIDUAL WITH DEVELOPMENTAL DISABILITY ASKS THAT DISCLOSURE TO THE PARENT OR GUARDIAN NOT BE ALLOWED, AN ADULT:
 - (3) A LAWYER OR OTHER INDIVIDUAL WHO IS AUTHORIZED:
- (I) BY THE INDIVIDUAL WITH DEVELOPMENTAL DISABILITY; OR
- (II) BY ANOTHER INDIVIDUAL TO WHOM, ON BEHALF OF THE DEVELOPMENTALLY DISABLED INDIVIDUAL, DISCLOSURE OF THE RECORD IS AUTHORIZED; OR
- (4) THE CASE MANAGER FOR AN INDIVIDUAL WITH DEVELOPMENTAL DISABILITY OR SERVICE COORDINATOR WHO PROVIDES OR COORDINATES SERVICES IN ACCORDANCE WITH THE PLAN OF HABILITATION FOR THE INDIVIDUAL WITH DEVELOPMENTAL DISABILITY.":

and in line 18, strike "(d)" and substitute "(E)".
