8	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

- 10 (A) THIS SECTION APPLIES TO CLAIMS UNDER A MOTOR VEHICLE LIABILITY 11 INSURANCE POLICY FOR:
- 12 (1) BODILY INJURY OR DEATH ARISING FROM A MOTOR VEHICLE 13 ACCIDENT; OR
- 14 (2) PROPERTY OF OTHERS DAMAGED OR DESTROYED IN A MOTOR 15 VEHICLE ACCIDENT.
- 16 (B) IF AN INSURER PAYS A CLAIM SUBJECT TO THIS SECTION TO A PERSON
 17 OTHER THAN THE NAMED INSURED, THE INSURER SHALL SEND WRITTEN NOTICE OF
 18 THE PAYMENT TO THE NAMED INSURED WITHIN 30 DAYS AFTER THE PAYMENT IS
