- 5 take effect on the taking effect of the termination provision specified in Section 2 of
- 6 Chapter 528 of the Acts of the General Assembly of 2002. If that termination provision
- 7 takes effect, Section 1 of this Act shall be abrogated and of no further force and effect.
- 8 This Act may not be interpreted to have any effect on that termination provision.
- 9 SECTION 5. AND BE IT FURTHER ENACTED, That, subject to the provisions 10 of Section 4 of this Act, this Act shall take effect June 1, 2003.
