## 2 Somerset County - Ferry Companies - Franchises

- 3 FOR the purpose of authorizing the County Commissioners of Somerset County to
- 4 grant one or more franchises for a ferry company to operate between Somerset
- 5 County and Reedville, Virginia, on a nonexclusive basis; requiring the County
- 6 Commissioners of Somerset County to review a certain proposed business and
- 7 financial plan at a certain time; authorizing the County Commissioners of
- 8 Somerset County to adopt certain regulations that are consistent with certain
- 9 regulations adopted by the Public Service Commission; prohibiting a ferry
- 10 company granted a franchise under this Act from conducting certain gambling
- or gaming activities on any ferry that it operates under the franchise; and

- 22 (a) (3) (I) NOTWITHSTANDING ANY ANTICOMPETITIVE EFFECT, THE
- 23 COUNTY COMMISSIONERS OF SOMERSET COUNTY MAY GRANT ONE OR MORE
- 24 FRANCHISES FOR A FERRY COMPANY TO OPERATE BETWEEN SOMERSET COUNTY
- 25 AND REEDVILLE, VIRGINIA ON A NONEXCLUSIVE BASIS.
- 26 (II) BEFORE GRANTING A FRANCHISE FOR A FERRY COMPANY, THE
- 27 COUNTY COMMISSIONERS OF SOMERSET COUNTY SHALL REVIEW THE PROPOSED
- 28 BUSINESS AND FINANCIAL PLAN FOR THE FERRY COMPANY.

- 1 (III) 1. THE COUNTY COMMISSIONERS OF SOMERSET COUNTY 2 MAY ADOPT REGULATIONS TO CARRY OUT THE PROVISIONS OF THIS PARAGRAPH.

- 4 SHALL BE CONSISTENT WITH ANY REGULATIONS ADOPTED BY THE PUBLIC SERVICE
- 5 COMMISSION THAT RELATE TO FERRY COMPANIES.
- 6 (IV) A FERRY COMPANY THAT IS GRANTED A FRANCHISE UNDER
- 7 THIS PARAGRAPH MAY NOT CONDUCT GAMBLING OR GAMING ACTIVITIES
- 8 PROHIBITED UNDER THE CRIMINAL LAW ARTICLE ON ANY FERRY THAT IT OPERATES
- 9 UNDER THE FRANCHISE.
