10 of the matching fund or what money or assets may qualify as matching funds, the 11 Board of Public Works shall determine the matter and the Board's decision is final. 12 The grantee has until June 1, [2003] 2005 2004, to present evidence satisfactory to 13 the Board of Public Works that a matching fund will be provided.
