2 State Government - Buildings - Green Buildings

- 3 FOR the purpose of requiring that the design, construction, operations, maintenance,
- 4 and deconstruction of certain new buildings conform to a certain rating adopted
- 5 by the Maryland Green Buildings Council; requiring that reasonable efforts be
- 6 made by units of State government to maximize the use of energy efficiency and
- 7 resource conservation techniques in certain existing State buildings; and
- 8 generally relating to the design, construction, operations, maintenance, and
- 9 deconstruction of State owned or leased buildings or buildings constructed on
- 10 land leased from the State.

- Section 4-901 to be under the new subtitle "Subtitle 9. Green Buildings"

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

- 19 SUBTITLE 9. GREEN BUILDINGS.

- 21 (A) THE DESIGN, CONSTRUCTION, OPERATIONS, MAINTENANCE, AND
- 22 DECONSTRUCTION OF ALL NEW STATE-OWNED AND LEASED BUILDINGS SHALL
- 23 CONFORM TO THE SILVER RATING OF THE U.S. GREEN BUILDING COUNCIL'S LEED
- 24 (LEADERSHIP IN ENERGY AND ENVIRONMENTAL DESIGN) GREEN BUILDING RATING
- 25 SYSTEM AS ADOPTED BY THE MARYLAND GREEN BUILDINGS COUNCIL.
- 26 (B) THE DESIGN, CONSTRUCTION, OPERATIONS, MAINTENANCE, AND
- 27 DECONSTRUCTION OF ALL NEW BUILDINGS CONSTRUCTED ON LAND LEASED FROM
- 28 THE STATE SHALL CONFORM TO THE SILVER RATING OF THE U.S. GREEN BUILDING

- 4 (C) REASONABLE EFFORTS SHALL BE MADE BY UNITS OF STATE
- 5 GOVERNMENT TO MAXIMIZE THE USE OF ENERGY EFFICIENCY AND RESOURCE
- 6 CONSERVATION TECHNIQUES IN ALL EXISTING STATE-OWNED, LEASED, OR
- 7 OPERATED BUILDINGS.
- 8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 9 October 1, 2003.
