21 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 22 MARYLAND, That the Laws of Maryland read as follows:

- 3 (i) "Program" means the Maryland Medical Assistance Program.

- 5 (a) The Department shall adopt rules and regulations for the reimbursement
- 6 of providers under the Program. However, except for an invoice that must be
- 7 submitted to a Medicare intermediary or Medicare carrier for an individual who may
- 8 have both Medicare and Medicaid coverage, payment may not be made for an invoice
- 9 that is received more than 1 year after the dates of the services given.

- 11 (A) THIS SECTION DOES NOT APPLY TO A PERSON PROVIDING PHARMACY
- 12 BENEFIT MANAGER SERVICES.
- 13 (B) IF A PHARMACY IS REQUIRED TO SUBMIT A REQUEST FOR PAYMENT
- 14 ELECTRONICALLY TO THE DEPARTMENT UNDER § 15-105(A) OF THIS SUBTITLE, THEN
- 15 THE PHARMACY MAY CHOOSE TO BE REIMBURSED ELECTRONICALLY, AND IN THAT
- 16 EVENT, THE DEPARTMENT SHALL REIMBURSE THE PHARMACY ELECTRONICALLY
