- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 17 MARYLAND, That the Laws of Maryland read as follows:

- 20 (L) A CUSTODIAN MAY DENY INSPECTION OF ANY PART OF A PUBLIC RECORD
- 21 THAT CONTAINS INFORMATION RELATED TO A PROPOSAL FOR FINANCIAL OR
- 22 COMMERCIAL ASSISTANCE GENERATED, RECEIVED, OR IN THE PROCESS OF BEING
- 23 NEGOTIATED BY THE DEPARTMENT OF BUSINESS AND ECONOMIC DEVELOPMENT, IF
- 24 THE PUBLIC RECORD WAS GENERATED, RECEIVED, OR IN THE PROCESS OF BEING
- 25 NEGOTIATED PRIOR TO:
- 26 (1) THE EXECUTION BY THE DEPARTMENT OF BUSINESS AND
- 27 ECONOMIC DEVELOPMENT AND ALL OTHER PARTIES TO THE PROPOSED FINANCIAL

- 1 OR COMMERCIAL ASSISTANCE OF ALL FINAL COMMITMENT LETTERS RELATED TO
- 2 THE PROPOSED FINANCIAL OR COMMERCIAL ASSISTANCE; OR
- 3 (2) THE FINAL APPROVAL OF THE PROPOSED FINANCIAL OR
- 4 COMMERCIAL ASSISTANCE BY THE LEGISLATIVE POLICY COMMITTEE OF THE
- 5 GENERAL ASSEMBLY, IF THAT APPROVAL IS REQUIRED BY LAW.

- 7 July 1, 2003.
