16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

17 MARYLAND, That the Laws of Maryland read as follows:

20 (o) (1) In addition to and not in substitution for any powers granted under

21 this subtitle, the county commissioners of Dorchester, Garrett, and Somerset counties

22 may by ordinance provide for a comprehensive system for the regulation of dogs and

23 cats within the county, including licensing and control. These regulations may include

24 provision for the impounding and disposal of unlicensed or dangerous dogs and cats

25 and penalties, including in Dorchester County AND GARRETT COUNTY civil or

26 criminal penalties, for violations of any of the provisions of the regulations.

4 (a) Any person violating or refusing to comply with any of the provisions of 5 this subtitle is guilty of a misdemeanor and shall be fined not less than \$5 nor more 6 than \$25 or shall be imprisoned in the county jail for not more than 30 days, or shall 7 be both fined and imprisoned. The State's Attorney and the sheriffs of the several 8 counties shall prosecute all persons found violating the law by refusing to comply with 9 its provisions.

10 (b) In Calvert County the fine is \$50 or 60 days.

11 (c) This subtitle does not apply to the City of Baltimore, the City of 12 Cambridge, or the City of Crisfield.

13 (d) This section does not apply in Washington County.

14 (e) THIS SECTION DOES NOT APPLY IN GARRETT COUNTY.

15 (F) This section does not apply to a violation of § 11-512, § 11-513, or § 11-514 16 of this subtitle.

17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 2003.
