[Subject to subsection (b) of this section, an] AN individual who is 16 receiving a service retirement allowance or vested allowance may accept employment 18 with a participating employer on a permanent, temporary, or contractual basis, 19 without any reduction in the allowance, if: 20 the individual immediately notifies the Board of Trustees of the (1) 21 individual's intention to accept the employment; and 22 (2) the individual specifies the compensation to be received.

This subsection does not apply to:

1 (ii) an individual who is serving in an elected position as an official 2 of a participating governmental unit or as a constitutional officer for a county that is 3 a participating governmental unit. 4 The Board of Trustees shall reduce an individual's allowance by the (2)5 amount that the sum of the individual's initial annual basic allowance and the 6 individual's annual compensation exceeds the average final compensation used to 7 compute the basic allowance. 8 An individual who is receiving a service retirement allowance or a vested (c)9 allowance and who is reemployed by a participating employer may not receive 10 creditable service or eligibility service during the period of reemployment. 11 [(d)](C) The individual's compensation during the period of reemployment 12 may not be subject to the employer pickup provisions of § 21-303 of this article or any 13 reduction or deduction as a member contribution for pension or retirement purposes. 14 The State Retirement Agency shall institute appropriate reporting 15 procedures with the affected payroll systems to ensure compliance with this section. 16 [(f) Immediately on the employment of any individual receiving a service (1) 17 retirement allowance or a vested allowance, a participating employer shall notify the 18 State Retirement Agency of the type of employment and the anticipated earnings of 19 the individual. 20 At least once each year, in a format specified by the State Retirement 21 Agency, each participating employer shall provide the State Retirement Agency with 22 a list of all employees included on any payroll of the employer, the Social Security 23 numbers of the employees, and their earnings for that year.]
